#### ORDINANCE NO. 2013-10-\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF MCKINNEY, TEXAS, RELATING TO FEES, BY AMENDING CHAPTER 30. AVIATION, SECTION 30-86, SECTION 30-175, AND SECTION 30-205; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

- WHEREAS, the City Council of the City of McKinney, Texas, finds, determines, and declares that certain fees are necessary to provide for efficient airport services; and
- WHEREAS, the City Council of the City of McKinney, Texas, finds and determines that the current fees are insufficient to cover the costs of the respective services; and
- **WHEREAS**, the City Council of the City of McKinney, Texas desires to adopt fees necessary for the City to provide good and efficient government for the benefit of the citizens of the City.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

- Section 1. That the findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.
- Section 2. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Chapter 30, Sections 30-86, Section 30-175, and Section 30-205, are hereby amended, to read as follows:

- The City Manager, or his designee, may decrease the established rates Section 3. and charges for fuel and petroleum products by up to 10% of the Retail Price when demand or consumption patterns from a customer, or customers, indicates such a decrease will improve the net revenues for budgeted sales versus actual sales in any pricing tier or category. The City Manager will notify the City Council of any rate adjustments by written report within sixty days of the adjustment. "Retail Price" shall be the aggregate of all components of rates and charges for fuel and petroleum products (cost, tax, markup, discount) in Section 30, Appendix A.
- Section 4. That fees and charges set forth in Section 2 of this Ordinance relating to Section 30-86, Section 30-175, and Section 30-205, supercedes any conflicting sections in Chapter 30 of the Code of Ordinances.
- Section 5. That if any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.
- Section 6. That this Ordinance shall be cumulative of all other ordinances of the City and shall not repeal any of the provisions of said ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance and such ordinances shall remain intact and are hereby ratified, verified and affirmed.
- Section 7. This Ordinance shall become effective upon passage.
