

WHY WE SUPPORT TRAVEL

TRAVEL AND TOURISM ARE VITAL TO THE TEXAS ECONOMY. In 2019, the industry had an economic impact of more than \$169 billion dollars to the Texas economy, and had both direct and secondary impacts on many other industries from transportation to construction. Travel and tourism is among the largest export industries in the state, second only to oil and gas, and a significant contributor to tax revenues from hotel occupancy to alcoholic beverage taxes.

TRAVEL MEANS JOBS. One out of every 10 Texas jobs is supported by travel and tourism. The industry encompasses hotels, restaurants, airlines and airports, attractions, destinations, and other businesses that create more than 1.3 million jobs in Texas.

LEGISLATIVE FOCUS AREA: ECONOMIC GROWTH

The travel industry is a significant economic driver for the Texas economy. Travel and tourism is among the largest export industries in the state, second only to oil and gas, and a significant contributor to tax revenues from hotel occupancy to alcoholic beverage taxes. Travel spending in Texas helps to lower the overall tax bill for every Texas household.

For example, in 2018, due to travel spending in Texas, each Texas household paid \$740 less in taxes. In 2018, according to data from the Governor's Office of Texas Economic Development & Tourism Office, a total of \$80.3 billion in direct travel spending was recorded in Texas (by travelers to and within Texas). That travel spending generated \$4.5 billion in state taxes and \$3.0 billion in local taxes. Many local economies have suffered significant financial losses and are now facing massive budgetary shortfalls due to the lack of tax revenues generated by travel and tourism, which they rely on to fund much of their budgets. We support the dedicated use of travel promotion marketing.

The travel industry in Texas has a significant impact on hotel occupancy taxes, which are a critical funding tool for developing local economies in Texas communities. Local hotel occupancy tax revenues are dedicated by state statute to only fund activities, facilities, and programs that directly promote tourism and hotel activity. It is an industry priority to preserve the integrity of state and local hotel occupancy taxes.

Property taxes are integral to school finance as well as to creating a favorable business climate in Texas. We support property tax reforms that will hold the line on growth as well as preserve Texas' competitive position in the domestic and international travel market. The Texas travel industry supports policies that will help revitalize our state and local economies, allowing the travel industry to contribute much-needed tax revenues to fuel public services, education, and other critical community needs as we begin to recover from this devastating pandemic.

Legislation we will support/monitor/oppose may include:

- Hotel Occupancy Tax usage
- Shared economy regulations
- Property tax relief for businesses and consumers

LEGISLATIVE FOCUS AREA: WORKFORCE DEVELOPMENT

The industry offers opportunities for entry, advancement, and full career growth in varied areas from management, finance, marketing, customer service, human resources, and more.

We support programs and policies that enhance the vibrancy of the Texas workforce. We will continue to work with the Texas Education Agency (TEA) to preserve and enhance the certification programs that contribute to the readiness of the travel industry's up and coming workforce, create teacher externships and student internships to provide for a more robust learning experience and understanding of the lifelong opportunities for growth that exist in the industry. We will continue to work with other business associations and partners to ensure pro-business policies are enacted that enhance our ability to create jobs.

Cities in Texas have begun passing ordinances that require private businesses to increase wages above the Federal Minimum, provide Mandatory Paid Time Off or Paid Sick Leave, and install Predictive Scheduling. The Texas Appeals Court has ruled these policies unconstitutional, stating that a law mandating sick leave is a law regulating wages and is the State's purview to set, not that of a city. Local employment ordinances often hamper the ability of businesses to grow and hire more Texans. We will continue to work with Legislators, affected businesses and business associations to pass legislation pre-empting local ordinances that interfere with business operations and a business owners' right to make their own business decisions or hamper their ability to succeed.

Legislation we will support/monitor/oppose may include:

- Local employment ordinances
- Promotion of Texas as a place where businesses and travelers are welcome
- Full summer seasonal employment opportunities

LEGISLATIVE FOCUS AREA: TRANSPORTATION INFRASTRUCTURE

Travel to and within Texas relies on strong infrastructure. Whether visitors drive, fly, or travel by rail, all modes of transportation in Texas are important to the growth of the travel industry and our ability to contribute to the State and local economies. We support programs and initiatives that advance travel mobility to and within Texas, including projects like Ports to Plains, high speed rail initiatives, and the work of the Texas Department of Transportation (TxDOT).

We also work collaboratively with the Texas Commercial Airports Association (TCAA) to advance and modernize commercial airports in Texas, enhancing their ability to contribute to the State and local economies.

Legislation we will support/monitor/oppose may include:

- Funding for Commercial airport modernization/expansion
- Funding for transportation projects such as Ports to Plains or high-speed rail projects

Legislation we will support/monitor/oppose may include:

- Traveler accessibility programs/education initiatives
- Ride regulations for amusement parks, waterparks, or like entities
- Animal-related legislation that may impact the industry
