

CITY COUNCIL SPECIAL MEETING & WORK SESSION

SEPTEMBER 22, 2020

The City Council of the City of McKinney, Texas met in Special Session & Work Session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, September 22 at 3:00 p.m.

There were approximately four (4) members of the public present.

Mayor Fuller called the meeting to order at 3:00 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for Public Comments.

Council unanimously approved the motion by Council Member Elliott, seconded by Council Member Franklin, to Approve Amending Resolution No. 2020-07-096(R) Authorizing the Creation of an Ad Hoc Throckmorton Statue Advisory Board to Oversee Staff and Expert Research Related to the Throckmorton Statue Located on City-Owned Property; Providing for an Amended Charge to Said Board; and Providing for an Effective Date

Mayor Fuller called for Council and Manager Comments:

Council Member Philips commended Matthew Jeter for is athletic ability and thanked all participants involved in the recreation leagues the City offers. Council Member Philips called attention to the great job that the McKinney Parks and Recreation Department is doing. Council Member Philips also recognized Corbin Ringley who traveled to St. Charles, Louisiana to assist with the relief effort after the hurricane.

Council Member Elliott thanked Bill Krueger and Kimberly Wood for serving as the Alternant Member on the McKinney Economic Development Corporation (MEDC). Council Member Elliott welcomed Kirk Kuehn to the MEDC. Council Member Elliott stated that the MEDC is able to do great things, because of the great people that they have.

Council Member Shemwell sought consensus from the Council to task City staff to produce a flyer to assist in the housing effort of evacuees from Hurricane Laura. It came to Council Member Shemwell's attention that they do not have access to laundry facilities where they have been placed and seeks to provide relief. Council Member

Shemwell also commented on that we are what our reputation is and harboring our negative past can hamstring our future.

Mayor Fuller commented on Council Member Shemwell's efforts and offered to print the flyers in partnership with the Love Life Foundation.

Mayor Fuller recessed the Special Meeting at 4:25 p.m.
