

ORDINANCE NO. 2017-06-\_\_\_

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, DESIGNATING RESERVED PARKING FOR LAW ENFORCEMENT ONLY ON THE WEST SIDE OF CHESTNUT STREET BETWEEN DAVIS STREET AND CLOYD STREET IN MCKINNEY AND TWO ADDITIONAL PARKING SPACES IN THE PUBLIC PARKING LOT ADJACENT TO THE MCKINNEY POLICE DEPARTMENT STOREFRONT IN MCKINNEY, TEXAS; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The City Council of the City of McKinney, Texas, hereby repeals Section 62-420 of the Code of Ordinances.
- Section 2. The City Council of the City of McKinney, Texas, hereby amends Section 62 – 420 (2) of the Code of Ordinances, which will read as follows:  
(2) On the west side of Chestnut Street beginning at the intersection of Davis Street and extending northward to the intersection of Cloyd Street
- Section 3. The City Council of the City of McKinney, Texas, hereby amends Section 62 – 420 (3) of the Code of Ordinances, which will read as follows:  
(3) Three parking spaces adjacent to the north side of the McKinney Police Department Storefront and west of the Kentucky Street in the parking lot near the intersection of Kentucky Street and Davis Street.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.
- Section 5. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
