

**RESOLUTION NO. 2017-02- \_\_\_\_ (R)**

**A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, IN SUPPORT OF THE APPLICATION BY EVERGREEN AT MCKINNEY SENIOR COMMUNITY, L.P. TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS (TDHCA) FOR TAX CREDITS FOR THE EVERGREEN AT MCKINNEY COMMUNITY, LOCATED IN THE 8800 BLOCK OF SILVERADO TRAIL; MAKING FINDINGS RELATED TO THE SUBJECT; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS,** Evergreen at McKinney Senior Community, L.P. is proposing to construct Evergreen at McKinney Senior Community, a 130 unit, affordable, multifamily development, located in the 8800 block of Silverado Trail, on the easternmost part of a tract at the NEQ of Silverado Trail and Custer, (the "Project") in the City of McKinney, Collin County, Texas (the "City"); and

**WHEREAS,** Evergreen at McKinney Senior Community, L.P. has provided notice to the City in accordance with Chapter 2306 of the Texas Government Code of its intent to file its application with the Texas Department of Housing and Community Affairs (the "TDHCA") for 9% tax credits for the development of the Project and has requested from the City issuance of a Resolution of Support of the Project as part of Evergreen at McKinney Senior Community, L.P.'s application to TDHCA; and

**WHEREAS,** City staff has reviewed the Project in accordance with the City of McKinney Low Income Housing Tax Credits Resolution Policy; and

**WHEREAS,** the City has had sufficient opportunity to obtain a response from Evergreen at McKinney Senior Community, L.P. regarding any questions or concerns about the Project; and

**WHEREAS,** the City conducted a public hearing in accordance with Chapter 2306 of the Texas Government Code so that public comment may be made on the Project; and

**WHEREAS,** the City of McKinney understands the importance of the low income housing tax credits program and the ability of developers to invest in and construct affordable housing.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, COLLIN COUNTY, TEXAS, THAT:**

Section 1. The foregoing premises are incorporated herein by reference.

Section 2. After due consideration of the information provided by Evergreen at McKinney Senior Community, L.P. and public comment, the City of McKinney, acting through its governing body, supports the application submitted to the TDHCA for the Project and its proposed location within

the City of McKinney.

Section 3. The City of McKinney's support of the Project is based on the following legislative findings: \_\_\_\_\_.
