### **FY 21 Grants**

The FY21 Grant calendar is included in this update. The first deadline coming up is for the first round of Promotional and Community Event Grants. Applications will be accepted through Monday, November 30. This year \$100,000 has been allocated for each of two rounds.

Applications will be accepted December 1 through December 30 for the first round of Project Grants.

Applications will be accepted January 1 through January 29 for the first round of Retail Development Infrastructure Grants.

### **TUPPS Brewery Expansion**

A kick-off meeting for the project team was held October 29<sup>th</sup>. Twice-monthly progress meetings will be held for the duration of the project. Design and site layout are in process. A pre-development meeting with the city staff is scheduled for later this month.

### **Strategic Priorities**

MCDCC board members began discussion regarding strategic priorities for project funding at the October meeting with a review of progress toward priorities established for FY19 and FY 20. The information provided is included with this update. Discussion will continue during the November meeting.

## **Marketing**

The "Buy McKinney – Spend it Here. Keep it Here" and "It's My McKinney" campaign was initiated one year ago. This month a direct mail piece, that includes messaging about support for local business, the campaign initiative to encourage consumer spending with local businesses and the impact that has on the community - along with a Buy Local sticker for display - will go out to 3,400 small business locations in McKinney. Work continues to integrate and cross-promote messaging about the importance of Buy Local with our community partners and businesses. Additionally, messaging is being integrated into marketing collateral for projects funded by MCDC to demonstrate how sales tax revenue generated through local dining and shopping is invested in the community. Examples include the Fitness Court at Bonnie Wenk Park (full campaign incorporated into design of court), Senior Center renovations (sign on-site) and Chestnut Square building renovations (yard signs placed at buildings/projects funded).

The comprehensive marketing, advertising and promotional campaign developed in late 2019 will continue this year.
