## LANDSCAPE NOTES

- 1. All landscaped areas shall be watered by an undergound automatic irrigation system with rain and freeze sensors and evapotranspiration (ET) weather based controller and shall be designed and installed by a qualified licensed irrigator. System shall comply with the City of McKinney's water conservation ordinance.
- 2. Backfill all planting pits using a 1:1 mix of parent soil from planting pit (void of rocks or other debris) and an approved planting mix composed of minimum 75% composted amendments.
- 3. Install 3" layer of shredded hardwood mulch to all tree
- 4. Shredded hardwood mulch must be contain long strands along with double shred finer material obtained from a local source.
- 5. Install 2 inches of clean topsoil in all areas of the site disturbed by grading and construction operations. Topsoil shall be free from sticks, debris and rocks larger than 2 inches in diameter and have an organic matter level of 3 percent minimum and a pH range between 5.5 and 7.4 percent. Provide soil test analysis from a soil test laboratory showing soil makeup and organic percentage.
- 6. All landscape areas shall be protected by a monolithic curb or wheel stops and remain free of trash, litter, and car bumper overhangs.

Total Site Area = 3.6961 ac. (161,002 s.f.)


