ORDINANCE NO. 2013-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS ESTABLISHING A SCHOOL ZONE AND CROSSWALK LOCATIONS AT LINDSEY ELEMENTARY SCHOOL IN McKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF McKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 346, which will read as follows:

Sec 62-346. Lindsey Elementary School – Zone Designated.

The Lindsey Elementary School zone shall be:

- (1) On Wilford Drive beginning at a point 135 feet west of Sugar Valley Road and extending eastward to Berkley Drive.
- (2) On Berkley Drive beginning at a point 125 feet south of Leven Lane and extending northward to Colt Lane.
- (3) On River Crossing beginning at a point 75 feet south of Rancho Lane and extending southward to Colt Lane.
- (4) On Colt Lane beginning at River Crossing and extending eastward to Jubilee Drive.
- (5) On Jubilee Drive beginning at Colt Lane and extending northward to a point 95 feet south of Fern Valley Lane.
- Section 2. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 346.1, which will read as follows:

Sec 62-346.1 Same – Speed.

The speed limit for the vehicles traveling the streets within the Lindsey Elementary School zone during the hours of 7:10 a.m. to 8:10 p.m. and 2:40 p.m. to 3:40 p.m., school days, shall be 20 miles per hour maximum.

Section 3. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 346.2, which will read as follows:

Sec 62-346.2 Same - Crosswalks.

Crosswalks shall be established at the Lindsey Elementary School zone as follows:

- (1) On Wilford Drive along the east side of the intersection with Sugar Valley Road.
- (2) On Berkley Drive along the north side of the intersection with Hampshire Drive.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.
- Section 5. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
