- **WHEREAS**, the 2013-14 budget for the City of McKinney includes \$185,000.00 for the support of arts groups operating in the City of McKinney; and
- **WHEREAS,** the City Council of the City of McKinney, Texas, finds and determines the following funding accomplishes a public purpose and municipal purpose for the City of McKinney.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The foregoing recitals are hereby found to be true and correct legislative findings of the City of McKinney, Texas, and are fully incorporated into the body of this resolution.
