Agency Name	Amount Requested	Program Description
Health Services of North Texas	\$6,500	Funding to support the salary of the LCSW providing Behavioral Health Counseling to persons living with HIV/AIDS.
The Samaritan Inn	\$13,500	Funding to support the salary of the Case Manager providing services for McKinney shelter residents.
Communities In Schools of the North Dallas Region	\$15,000	Funding for the CISDR Program at Caldwell Elementary that will provide comprehensive academic and support services for at-risk students the 2014-15 school year.
Community Lifeline Center	\$10,000	Funding for Emergency Rental and Utility assistance for McKinney residents.
The Salvation Army	\$20,000	Funding for Emergency Rental, Utility, and Mortgage assistance for McKinney residents.
North Collin County Habitat for Humanity	\$50,000	Funding to acquire 5 plots to build affordable homes.
McKinney ISD	\$8,000	Funding for "Unidad en la Comunidad-Unity in the Community" Program, which provides bilingual mental health services to MISD students, families, and relatives.

Volunteer McKinney	\$21,000	Funding to support the intern salary whose primary responsibility will be organizing and implementing the Youth Empowerment Summit.
Maurice Barnett Geriatric Wellness Center	\$12,132	Funding support the salary of a Social Work-Case Manager that will provide in-home services to adults aged 62 & older, allowing them to remain independent.
CASA of Collin County	\$15,000	Funding to support the salaries of CASA Recruiters & Trainers that provide supervision and training of CASA volunteers.
City of McKinney-Grant Administration	\$146,149	Statutory Law- only 20% of total grant used, city budget process
City of McKinney-Public Services	\$109,612	Statutory Law-15% of total grant can be allocated. 12 agencies under consideration.
City of McKinney-Economic Development, Housing Rehab, Acquisition & Infrastructure	\$474,986	Funding of city's programs, city budget process. 2 agencies under consideration for Acquisition & Infrastructure.
