MEDC Management Audit - Interim City Manager Muehlenbeck and I met with David W. Eisenlohr, President of The Azimuth Group, on November 2nd to kick off the MEDC management audit. The targeted management audit completion date is January 15, 2016. Three additional meetings are planned.


