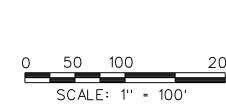

STATE OF TEXAS COUNTY OF COLLIN LEGAL DESCRIPTION

BEING a tract of land situated in the John W. Cox Survey, Abstract No. 160, in the City of McKinney, Collin County, Texas and being out of that Final Boundary Plat of Parcels 1201-1209, 1216 & 1217, an addition to the City of McKinney as recorded in Cabinet 0, Pages 269 & 270 in the Plat Records of Collin County, Texas, and being more particularly described as follows:

BEGINNING, at a ½ inch iron rod found at the northwest corner of The Heights At Westridge Phase III, being an addition to the City of McKinney, as recorded in Volume 2007, Pages 554 & 555, in the Plat Records of Collin County, Texas, and being a point in the south line of Westridge Boulevard;

THENCE, South 13° 24'24" East, departing said south line and with the west line of said Phase III, at 713.81 feet passing a $\frac{1}{2}$ inch iron rod found at an exterior ell corner of said Phase III, and continuing for a total distance of 717.70 feet to a $\frac{1}{2}$ inch iron rod set;

Phase III, and continuing for a total distance of 717.70 feet to a $\frac{1}{2}$ inch iron rod set; THENCE, South 86° 28'12" West, for a distance of 568.64 feet to a $\frac{1}{2}$ inch iron rod set;

THENCE, North 89° 36'11" West, for a distance of 534.00 feet, to a $\frac{1}{2}$ inch iron rod set, being a point in the west line of said Final Boundary Plat of Parcels 1201-1209, 1216 & 1217, and in the east line of Coit Road;

THENCE, North 00°01'57" West, with said east and west lines for a distance of 374.77 feet to a $\frac{1}{2}$ inch iron rod set;

THENCE, North 03° 46'54" East, continuing along said lines, for a distance of 150.33 feet, to a $\frac{1}{2}$ inch iron rod set;

THENCE, North 00° 01'57" West, continuing with said lines for a distance of 129.30 feet to a $\frac{1}{2}$ inch iron rod set;

THENCE, North 45° 06'17" East, continuing with said lines, for a distance of 35.28 feet to a $\frac{1}{2}$ inch iron rod set being, the most northerly northwest corner of said Final Boundary Plat of Parcels 1201-1209, 1216 & 1217, being in the south line of Westridge Boulevard;

THENCE, South 89° 45'28" East, with said south line of Westridge Boulevard and being the north line of said Final Boundary Plat of Parcels 1201-1209, 1216 & 1217, for a distance of 113.00 feet to a $\frac{1}{2}$ inch iron rod set at the point of curvature of a curve to the left, having a radius of 265.00 feet, a tangent of 32.70 feet and a central angle of 14° 04'12";

THENCE, continuing along said north and south lines and said curve to the left for an arc distance of 65.08 feet (Chord Bearing North 83° 12'26" East - 64.91 feet), to a $\frac{1}{2}$ inch iron rod set at the point of reverse curvature of a curve to the right having a radius of 235.00 feet, a tangent of 29.00 feet and a central angle of 14° 04'12";

THENCE, continuing along said north and south lines and said curve to the right for an arc distance of 57.71 feet, (Chord Bearing North 83° 12'26" East - 57.56 feet), to a $\frac{1}{2}$ inch iron rod set at the point of tangency of said curve;

THENCE, South 89° 45'28" East, continuing with said north and south lines, for a distance of 665.94 feet to the POINT OF BEGINNING and containing 16.860 acres of land.

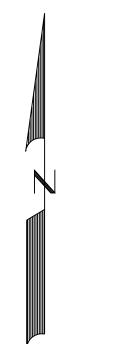

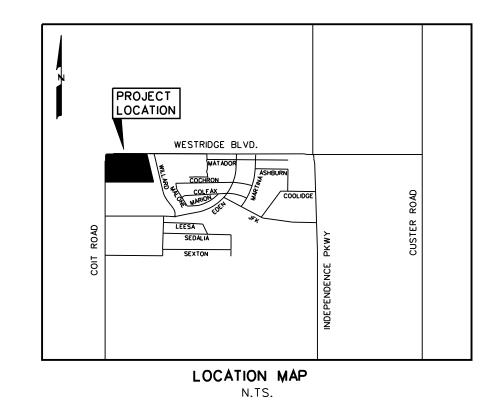
