

CITY COUNCIL REGULAR MEETING

OCTOBER 1, 2019

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, October 1, 2019 at 6:00 p.m.

Mayor George Fuller called the meeting to order at 6:00 p.m. with a quorum of the following Council Members: Mayor George Fuller, Mayor Pro Tem Rainey Rogers, and Council Members Scott Elliott, La'Shadion Shemwell, and Richard Franklin.

Council Members Charlie Philips and Frederick Frazier were absent from the meeting.

The following City of McKinney Staff were present: City Manager Paul Grimes, Assistant City Managers Barry Shelton and Steve Tilton, City Attorney Mark Houser, Strategic Services Manager Trevor Minyard, Assistant Director of Public Works Paul Sparkman, Facilities Construction Manager Patricia Jackson, Director of Parks & Recreation Michael Kowski, Police Chief Greg Conley, Police Officer Bruno Siqueira, Fire Chief Danny Kistner, Assistant Fire Chiefs Chris Lowry, Mike Smith and Robert Alley, Fire Public Information & Education Coordinator Merit Ossian, Planning Manager Aaron Bloxham, Video Producer Sidney Diongzon, and City Secretary Empress Drane.

There were approximately one hundred guests present.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance. The Invocation given by Assistant Fire Chief Chris Lowry, and the Pledge of Allegiance was led by members of the McKinney Fire Department.

Mayor Fuller called for the following Information Sharing items:

19-0799 Proclamation for Fire Prevention Month – Mayor Fuller read a proclamation recognition the importance of fire safety and prevention, commended the outreach and education efforts of the McKinney Fire Department, and encouraged the public to take part in becoming more educated in fire safety and prevention. Planning Manager Aaron Bloxham stated the request was withdrawn by the applicant, so no Council action was required. There were no citizen requests to speak on the item. Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Elliott, to close the public hearing.

Capital Improvements Project Manager Nick Ataie presented information regarding the item. The Capital Improvements Program includes funding for Wilmeth Road from Lake Forest Drive to Hardin Boulevard, approximately 8,450 linear feet, as a 4-lane divided greenway arterial. The project will also include the northbound lanes of Unnamed Arterial A (CR 943) from Ryeland Cove to Wilmeth Road (approximately 1,100 linear feet) and the southbound lanes of Hardin Boulevard from the existing terminus south of Holley Ridge Way to Wilmeth Road (approximately 1,550 linear feet). Once constructed, and upon completion of CIP Project ST1617 (Ridge Road from US 380 to

Wilmeth Road), Wilmeth Road will serve as a continuous/parallel route to US 380 between Ridge Road and SH 5. Mr. Ataie also noted several members of the Leadership McKinney Class of 2020 were in attendance. Council unanimously approved the motion by Mayor Pro Tem Rogers, seconded by Council Member Franklin, to approve a Resolution Authorizing the City Manager to Execute a Contract with Kimley-Horn and Associates, Inc. for Professional Engineering Design Services for the Wilmeth Road (Lake Forest Drive to Hardin Boulevard) Project (ST1719) and Authorizing Any Necessary Supplemental Agreements. Council Member Scott Elliott recused himself from discussion and action on this item (at 6:32 p.m., returning afterward at 6:35 p.m.) Community Services Administrator Shirletta Best explained the proposed allocation of funding:

The motion by Council Member Shemwell, seconded by Council Member Franklin, to approve a Resolution Funding Recommendations under the FY 2020 Community Support Grant carried with four members voting in favor, none voting against, with Council Member Elliott recused from the vote, and Council Members Frazier and Philips absent from the meeting. Resolution caption reads:

19-0814 Consider/Discuss/Act on Appointing a Member to the McKinney Historic Preservation Advisory Board

Council unanimously approved the motion by Council Member Elliott, seconded by Council Member Franklin, to Appoint a Member to the McKinney Historic Preservation Advisory Board. The appointed member Betty Petkovsek will replace alternate member Madhuri Mohan, who relocated outside of the city. The appointment term will be effective October 1, 2019 to September 30, 2021. Ms. Petkovsek's appointments leaves a vacancy at the Planning & Zoning Commission alternate position, which will be filled on October 15, 2019.

Mayor Fuller again called for Citizen Comments, at which time there were no requests to address the Council.

Mayor Fuller called for Council and Manager Comments.

Council Member Elliott thanked former Chair and Vice Chair of the McKinney Community Development Corporation for their service to the board:

“Thank you to David Clarke (Vice Chair) and Kurt Kuehn (Chair). It is a great board. They have done a great job, and they have helped make the board what it is today. When I visited the group last week, they embodied four things. I think we know people who are up people and people who are down people. When I say “up,” it was “study up.” They came prepared. They looked over the agenda. They looked over the material, and they were ready every time. The second “up” was “show up,” and I have to commend the board with overall the attendance has been stellar. The third is “speak up.” We want people to speak up, and last one was really “lift up.” I can’t think of a board more dedicated to lifting up the city as a whole. The culture that makes McKinney...we want people like that on our boards and commissions.”

Mayor Pro Tem Rogers commended all those involved with presenting the Oktoberfest event, including the Main Street Board and the McKinney Police, stating it was probably one of the most well-attended events and praising event coordinator Amy Rosenthal for doing a first-class job.

Council Member Shemwell thanked city staff and police department for swiftly responding to an incident which occurred earlier in the day. Mr. Shemwell expressed excitement for Parks & Recreation renovation projects in-progress on the east side of the city: Fitzhugh Park, Cottonwood Park and Old Settler’s Recreation Center. Mr. Shemwell stated his interest in meeting with city staff to address the issue presented by Sarah Pearson and Rick Ballard.

Council Member Franklin said 872,000 Oktoberfest tickets were sold (for food, beverages and activities) up from 812,000 last year; and 66,000 people attended throughout the weekend. Mr. Franklin thanked Amy Rosenthal, Main Street Board, McKinney Convention and Visitors Bureau, city staff and hundreds of volunteers who supported the event.

City Manager Paul Grimes praised the Oktoberfest event, Amy Rosenthal, city staff and Main Street Board, volunteers, first responders and downtown merchants for the concerted efforts to create a great event. City Manager announced the Communications and Marketing Department earned three awards at the 3MCA (City-County Communications & Marketing Association) annual conference, and four awards

from NATOA (National Association of Telecommunications and Advisors). The awards were earned from among more than 900 other entrants from across the country.

Mayor Fuller commended the Oktoberfest event at which his wife Maylee sang the National Anthem. Mayor Fuller thanked the police for ensuring safety of the city, and commended former MCDC members Kurt Kuehn and David Clarke for their service to that board. Mayor Fuller announced his and Maylee's recent celebration of their 25th wedding anniversary. Mayor Fuller also acknowledged the Leadership McKinney graduates, encouraging everyone to learn about the Leadership McKinney Program, and announced the State of the City event will take place on November 7, 2019 (the same day as his birthday), encouraging the public to attend and learn more about the things happening in the city.

The City Council did not meet in Executive Session.

The Council unanimously approved the motion by Council Member Elliott, seconded by Council Member Franklin, to adjourn. Mayor Fuller adjourned the meeting at 6:50 p.m.
