

ORDINANCE NO. 2014-08-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, RENAMING A SECTION OF F.M. 543 BETWEEN U.S. HIGHWAY 75 AND TRINITY FALLS PARKWAY AND NAMING A NEWLY CONSTRUCTED ROADWAY SECTION SITUATED BETWEEN U.S. HIGHWAY 75 AND FORMER F.M. 543; NAMING THE MCKINNEY NATIONAL AIRPORT AIRFIELD; NAMING THE COURTROOM THEATER AT THE MCKINNEY PERFORMING ARTS CENTER; NAMING EVENT ROOMS AT THE GATEWAY EVENTS CENTER; PROVIDING FOR NOTICE AND IMPLEMENTATION; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Texas Department of Transportation has transferred ownership of, and responsibility for, that portion of F.M. 543 situated between U.S. Highway 75 and Trinity Falls Parkway to the City of McKinney; and

WHEREAS, a new, as yet unnamed, street is being constructed from U.S. Highway 75 to that section of former F.M. 543, identified herein-above, and which street will be extended in the future to Custer Road; and

WHEREAS a name is needed for the McKinney National Airport Airfield; and

WHEREAS a name is needed for the Courtroom Theater in the McKinney Performing Arts Center; and

WHEREAS names are needed for eleven rooms at the Gateway Events Center.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. FINDINGS

The findings set forth above are found to be true and correct and are hereby incorporated into the body of this Ordinance for all purposes as if fully set forth herein.

Section 2. RENAMING F.M. 543 ROAD SEGMENT

The segment of former F.M. 543 situated between U.S. Highway 75 and Trinity Falls Parkway is hereby named “_____”.

Section 3. NAMING NEWLY CONSTRUCTED ROAD SEGMENT AND FUTURE EXTENSION

The newly constructed street extending from U.S. Highway 75 to the segment of former F.M. 543 (which road is herein-above named as _____) and its future extension to Custer Road is hereby named “_____”.

Section 4 WRITTEN NOTICE OF CHANGE IN STREET NAME AND CHANGE IN SIGNAGE

City staff shall provide written notice of the street name changes contained in Sections 2 and 3, above, together with the effective date of such street name changes to the United States Postal Service, all emergency service providers and governmental entities within whose jurisdiction such properties are situated, and the owners and tenants of all properties affected by the foregoing street name change. City staff shall also cause new signage reflecting said street name changes to be installed within a reasonable time period following the effective date of this Ordinance.

Section 5 **NAMING THE MCKINNEY NATIONAL AIRPORT AIRFIELD**

The McKinney National Airport Airfield is hereby named
“_____”.

Section 6 **NAMING THE COURTROOM THEATER IN THE MCKINNEY PERFORMING ARTS CENTER**

The Courtroom Theater in the McKinney Performing Arts Center is hereby named “_____”.

Section 7 **NAMING THE ROOMS IN THE GATEWAY EVENTS CENTER**

The rooms in the Gateway Events Center are hereby named

Section 8. **SEVERABILITY CLAUSE**

It is hereby declared to be the intention of the City Council that the words, phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of any such unconstitutional word, phrase, clause, sentence, paragraph or section.

Section 9. **REPEALER CLAUSE**

Any provision of any prior ordinance of the City, whether codified or uncodified, which is in conflict with any provision of this Ordinance, is hereby repealed to the extent of the conflict, but all other provisions of the ordinances of the City, whether codified or uncodified, which are not in conflict with the provisions of this Ordinance shall remain in full force and effect.

Section 10. **EFFECTIVE DATE**

This Ordinance shall become effective immediately upon its passage.
