## MCKINNEY COMMUNITY DEVELOPMENT CORPORATION

## **JANUARY 28, 2016**

The McKinney Community Development Corporation met in regular session in the Dowdy Board Room, 5900 S. Lake Forest Drive, McKinney, Texas, on January 28, 2016 at 8:00 a.m.

Minutes of the McKinney Community Development Corporation Meeting on December 17, 2015. Board members unanimously approved the motion by Vice Chairman Kuehn, seconded by Secretary Clarke, to approve the December 17, 2015 minutes.

Chairman Elliott called for the December Financial Report. Senior Financial Analyst Trevor Minyard reported that MCDC revenue is above budget YTD by 11.25%. Sales tax figures came in 8.85% above last year's collection through December. Expenditures are below budget in total, with personnel expenses coming in approximately \$11,500 under budget through December. The major driver of expenses to date is related to the MAFC. Through December, MCDC has made over \$3 million in capital expenditures related to MAFC construction. Mr. Minyard reminded the Board that the interactive monthly financial report is available online on the City of McKinney website.

Chairman Elliott reminded all involved how much they are appreciated.

City of McKinney – Senior Financial Analyst Trevor Minyard stated the City Council is holding their Strategic Planning Retreat this morning, and last Monday they selected the search firm for the City Manager position.

Main Street & MPAC – Main Street/MPAC Program Director Amy Rosenthal introduced Geoff Fairchild, Main Street/MPAC's new Special Events Coordinator. There are many wonderful events coming up in

McKinney Convention and Visitors Bureau - Administrative Assistant Vanesa Rhodes reported that McKinney has been selected as the designated sight for the Texas Downtown Association Convention. This will take place November 6-10, 2017. We will be using more than the Sheraton Hotel to accommodate this group, as they will be bringing 250-300 attendees. They will also be featuring the downtown/historic districts and using some of the downtown venues for workshops. MCVB received seven RFP's from the Texas Connect show that staff attended in Frisco last month.

McKinney Economic Development Corporation – Interim President Abby
Liu reported in the most recent MEDC Board meeting, the Board

approved four new projects to bring to the City of McKinney. Ms. Liu was invited to be a panelist speaker for the Collin County Association of Realtors last week with about 300 realtors in attendance. During the presentation, Ms. Liu was able to discuss many of the wonderful attributes of McKinney, including, but not limited to the McKinney Aquatic and Fitness Center. Also, as a reminder, next Saturday evening is the Chinese New Year's Gala, and two MCDC Board members will be attending.

Parks and Recreation - Director of Parks and Recreation Rhoda Savage reported staff is closing out four projects over the next few weeks. On February 4, bids will be opened for the Community Center's patio expansion. Today, staff had the kick-off meeting with the designer for the Tennis Courts, Shrickel Rollins and Associates. Staff finished coordination for the All-Abilities concept design for Bonnie Wenk Phase II and it's quickly moving forward. There are four trail projects in the design process and they are about 30% complete. Staff is currently interviewing two new design firms for Gray Branch and Scott Elementary. Staff is in negotiations with three different groups for some private-public The Master Plan Committee Tour is scheduled for partnerships. February 27, which will be followed up in March with a work session for an even deeper understanding of what is involved and the next steps. Assistant Director of Parks and Recreation Ryan Mullins reported the MAFC Manager position is currently being advertised and closes next Friday, February 5. So far, about 60 people from across the United States have applied. Interview appointments will get started at the end of next week. On another note, the Annual Daddy/Daughter Dance is Friday, February 5, and while parking is the biggest hindrance to this event, the intimacy the Community Center provides makes it pretty special. Another family fun event is the Towne Lake Trout Derby coming up on Saturday, February 20, which is co-sponsored by Texas Parks and Wildlife.

Chairman Elliott called for the President's Report. President Cindy Schneible mentioned she would like to go over a few of the highlights from the Presidents monthly report that was sent to the Board a few days ago. Ms. Schneible and the Board's marketing committee members, have met with the City's Communications and Marketing team to discuss plans for recognition of the 20th anniversary of MCDC. The first step was to develop messaging about the importance of buying local and the impact the funds generated have on quality of life in McKinney. In the Board packet is an ad that has been developed by the Marketing team that combines the buy local and 20th anniversary message. Based on the discussions held, the plan is to utilize events in McKinney, scheduled between April and the end of the year, that provide an opportunity to focus attention on projects and facilities funded by MCDC and made possible as a result of buying local. The Marketing committee will meet with the City's video producer, Karl Suchman and the Communications and Marketing team to discuss creation of a video as part of the overall Ms. Schneible indicated a meeting of the performance facility subcommittee will be scheduled to discuss next steps. The progress on the Aquatic and Fitness center is on schedule. The structure went vertical about a week ago, and if anyone has not had a chance to driveby, please do so. Tomorrow is the deadline for the Cycle I Project Grants, and a couple of applications have come in. Ms. Schneible spoke with Juli Smith concerning the All-Abilities Playground grant, and they will probably wait until the next cycle to submit their application. understood comments about the need for fundraising efforts outside of MCDC to make the project a success. Finally, as part of the Leadership McKinney and other leadership groups in the North Texas area, there is a Regional Leadership Day Luncheon on February 25, if anyone is interested we can secure the tickets for you.

The grant funds of \$6,000 requested will be used to advertise and promote the 2016 Crape Myrtle Run.

16-102 Chairman Elliott called for the Consideration/Discussion of the Promotional and Community Events Grant Application Submitted by Embrace Waiting Children, Inc., in the Amount of \$2,500 (PC#16-04) for Advertising and Promotion of the 2016 Fairways for Families Golf Marathon and 5K. Mary Wells, Program Manager, presented the goals and objectives of the 3<sup>rd</sup> Annual Families Golf Marathon and 5K. Funds raised from fundraising events are used to engage in a non-profit ministry helping churches and communities to support the care of orphans and neglected, abused and traumatized children. The grant funds of \$2,500 will be used to promote and advertise the 2016 Fairways for Families Gold Marathon and 5K.

Chairman Elliott called for the Consideration/Discussion of the Promotional and Community Events Grant Application Submitted by Heard Wildlife Museum, in the Amount of \$3,000 (PC#16-05) for Advertising and Promotion of the 2016 Texas Heritage Festival. Stephanie Jennings, Marketing Director presented the goals of the fundraising efforts of the 2016 Texas Heritage Festival. Funds are used by the Heard Wildlife Museum to not only enhance tourism to McKinney, but also for education about natural science, introducing the natural history of Collin County, and reconnecting people with the natural world. The grant funds of \$3,000 will be used for advertising and promotion of the 2016 Texas Heritage Festival.

Promotional and Community Events Grant Application Submitted by McKinney Main Street, in the Amount of \$15,000 (PC#16-07) for Advertising and Promotion of Arts in Bloom 2016. Amy Rosenthal, Director gave the presentation explaining the focus of Arts in Bloom as the annual spring arts festival of McKinney. In addition to showcasing the talent and work of local artists, the wine and craft beer aspect of the festival, along with other components, will provide an opportunity for Arts in Bloom to generate funds for Main Street that will be used for other events that will take place in Historic Downtown McKinney. Grant funds of \$15,000 will be used exclusively to promote and advertise for Arts in Bloom 2016.

Chairman Elliott called for the Consideration/Discussion of the Promotional and Community Events Grant Application Submitted by ManeGait Therapeutic Horsemanship, in the Amount of \$7,500 (PC#16-08) for Advertising and Promotion of the 2016 Gaitapalooza Event. LeAnn AuBuchon, Director of Marketing and Development gave the presentation explaining the goals and objectives of Gaitapalooza are to raise funds for ManeGait programs which increase the quality of life for adults and children with disabilities, raise awareness of ManeGait programs, and support the local community by promoting local businesses and providing a family-friendly activity for residents of McKinney and surrounding areas. The grant funds of \$7,500 will be used to promote and advertise for the 2016 Gaitapalooza.

Wendy Shelley, Smiles Core Committee Member gave the presentation explaining the goal of the 9<sup>th</sup> Annual Smiles Charity Concert which is to raise funds for their 11<sup>th</sup> home this year for a disabled veteran. The grant

funds of \$15,000 will be used for advertising and promotion of the 2016 Smiles Charity Concert.

Mark Cottam, Board member for the WERX gave the presentation explaining how the fundraising events will be used to continue to the work of the WERX incubator to nurture start-up technology businesses with the goal of keeping them in McKinney as they grow and become successful. The grant funds of \$11,000 will be used to promote and advertise the fundraising events to draw participants from throughout North Texas.

Chairman Elliott called for the Consideration/Discussion of the Promotional and Community Events Grant Application Submitted by McKinney Kiwanis, in the Amount of \$5,000 (PC#16-06) for Advertising and Promotion of the 2016 Historic McKinney Kiwanis Triathlon. Dennis Williams, Race Chairman gave the presentation explaining the goal of this event is to make a significant impact on the quality of life in McKinney by promoting the physical aspect of wellness and have chosen the triathlon route to incorporate the historic nature of McKinney and to draw new visitors to our town. The grant funds of \$5,000 will be used to promote and advertise the 2016 Historic McKinney Kiwanis Triathlon.
