**20-0379** Director Kowski led discussions on the prospective Parks projects and priorities for funding including the master plan. Discussed were the current projects in various phases such as the National Fitness Campaign outdoor gym at Bonnie Wenk Park, the completion of George Webb Park and Fitzhugh Park, renovations at McKissick Park, Hilltop Park, and Eubanks Park, and new sports field lighting at Al Ruschhaupt Soccer Complex. Median landscaping and plantings on White Street and Collin McKinney Parkway are also enhancing the streets of McKinney.

Renovations at Oak Hollow Golf Course, the Juanita Maxfield Aquatic Center, Old Settler's Park, the Senior Recreation Center and Pool, and Finch Park, and Cottonwood Park are on track for completion this year.

**20-0380** Parks Manager Baker introduced Elizabeth McIlrath, Project Manager with Dunaway and Associates to discuss the visioning and priorities for the Park Master Plan Update. All Board members were given a Priorities Ranking Form to provide feedback on Parks & Recreation offerings, to set goals and strategic implementations.
