

ORDINANCE NO. 2016-02-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AMENDING THE FISCAL YEAR 2015-2016 ANNUAL BUDGET AND 2016 - 2020 CAPITAL IMPROVEMENT PROGRAM TO FURNISH TRAFFIC SIGNAL EQUIPMENT FOR HARRY MCKILLOP BOULEVARD (FM 546) AND McDONALD STREET (SH 5); AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

WHEREAS, as required by City Charter, the Interim City Manager has prepared an amendment to certain appropriations and expenditures in Fiscal Year 2015-2016 Annual Budget and the 2016 - 2020 Capital Improvement Program; and

WHEREAS, the Interim City Manager submitted same to the City Council of the City of McKinney, Texas for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to Fiscal Year 2015-2016 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$44,567 in funds from the Texas Department of Transportation to the Capital Improvement Program Project TR1602, Traffic Signalization of FM 546 at SH 5.
- Section 3. The budget shall be amended by appropriating \$44,567 in the Street Construction Fund for TR1602, Traffic Signalization of FM 546 at SH 5.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
