

RESOLUTION

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY,
TEXAS, APPROVING THE 2010-2011 COMMUNITY SUPPORT GRANT
FUNDING ALLOCATIONS, AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City Council, established the Community Support Grant to support direct funding assistance for qualifying non-profit agencies serving the City of McKinney and its residents; and

WHEREAS, the Community Grants Advisory Commission for the City of McKinney received grant applications for 24 qualifying non-profit agencies totaling \$647,622; and

WHEREAS, the 2010-2011 Community Support Grant budget includes \$119,700 for grants to qualifying non-profit agencies; and

WHEREAS, the Community Grants Advisory Commission held two public hearings and prepared recommendations for Council acceptance of the use of Community Support Grant funds; and

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines the funding for the following qualifying non-profit agencies accomplishes a public purpose and municipal purpose for the City of McKinney.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:
