ORDINANCE NO. 2012-10-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS MODIFYING THE SCHOOL ZONES AT VARIOUS SCHOOLS IN McKINNEY; ESTABLISHING A CROSSWALK ON SILVERADO TRAIL AT BLUE MOON; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A **PENALTY CLAUSE**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- The City Council of the City of McKinney, Texas hereby amends Section Section 1. 62 – 344 (1) of the Code of Ordinances, which will read as follows:
 - (1) On Silverado Trail beginning at the western Comstock Elementary School property line and extending eastward to a point 200 feet east of Blue Moon Drive.
- The City Council of the City of McKinney, Texas hereby amends the Code Section 2. of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 341.1, which will read as follows:

Sec 62-341.1 Same - Crosswalks.

Crosswalk shall be established at the Scoggins Middle School as follows:

- (1) On Silverado Trail along the west side of the intersection with Blue Moon Drive.
- Section 3. The City Council of the City of McKinney, Texas hereby amends Section 62 – 332 (2) of the Code of Ordinances, which will read as follows:
 - (2) On Eden Drive beginning at a point 300 feet north of JFK Boulevard and extending southward to a point 320 east of Willard Drive.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.
- Section 5. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
