

## CITY COUNCIL REGULAR MEETING

**MARCH 2, 2021**

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, March 2, 2021 at 6:00 p.m.

Council Present: Mayor George Fuller, Mayor Pro Tem Rainey Rogers, and Council Members Charlie Philips, Scott Elliott, Frederick Frazier, Rick Franklin, and Angela Richardson-Woods.

Council Member Frazier participated remotely by phone for the duration of the meeting.

Member thanked Pastor Watley and his church in assisting distribution of bottled water to citizens.

Council Member Franklin spoke regarding the Vaccination Hub and thanked all the staff and volunteers who have assisted.

Council Member Frazier reminded citizens to help others who are still recovering from the Winter Storm. The Council Member spoke about the Mill House and their work with local artist in McKinney.

City Manager Grimes updated the Council on the following items:
