David R. Brooks is Chairman of the Board, President and CEO of Independent Bank Group. Under David's leadership the bank has grown to be one of the 10 largest banks headquartered in Texas while maintaining its base in McKinney.

David has served on many local Boards, Commissions, and City Council:

Through the Community Grants Program, Independent Financial awards funding to local nonprofits serving low-to-moderate income individuals and families across. These grants are directed towards projects and programs that support Community Development, Education, and Health & Human Services in the communities where we all live and work. Since 2017, the Community Grants Program has awarded over \$1.539M to 80 different organizations. CCMGA's flagship garden project is an outdoor learning laboratory where McKinney residents can discover research-	

based information about Earth-Kind principles and learn effective Earth-Kind landscaping methods applicable to their own home gardening. These gardens are not just ornamental. CCMGA's Vegetable and Potager Gardens at Myers Park have donated thousands of pounds of produce to local food pantries. In addition, CCMGA's high school scholarships, award-winning youth education outreach at McKinney's Caldwell Elementary School and varied activities in CCMGA's Children's Garden at Myers Park have made a positive impact in the lives of McKinney youth.

CCMGA's influence on QIL extends far wider than the gardens they manage. CCMGA's Speakers Bureau serves as a resource for local garden clubs and civic groups. CCMGA volunteers have participated in McKinney events, such as the "Newcomers Guide to Gardening" events, the AT&T Byron Nelson and the recent Wilson Creek Tree Planting Project. CCMGA has also shared funds raised through the association's special events by making donations and grants to local non-profits such as HUGS Greenhouse and McKinney Roots, among others. CCMGA's many plant sales, garden shows, workshops and "Walk in the Park" events over the years have brought many visitors to McKinney and increased positive awareness of the QIL in McKinney through the promotion and success of these events.

The organization's entire roster of 364 volunteer Master Gardeners is committed to improving the quality of life in McKinney and the surrounding community by providing research-based information on sustainable horticultural practices and environmental stewardship. Family Submission for Quality of Life Award

Family Health Center on Virginia

This health center opened January 2021. The facility provides medical, dental, behavioral health, and women's health services. The facility's location, near U.S. 75 in McKinney, makes it accessible to patients. The facility also offers telehealth, taxi vouchers, and pedestrian access from the downtown McKinney area.

Most patients are from McKinney but patients from other cities in Collin County and several other counties have been treated at the facility.

The facility is a critical access point for care, especially for those who are uninsured or underinsured. Those traveling to the facility from outside McKinney speak to the fact that there are so few options for health care access.

The facility, as of October 2021, had seen 4,500 unique patients with 18,000 clinical visits and expected the final 2021 number to reach 6,000 unique patients and 24,000 services. From January 2021 to October 2021 the clinic had 14,000 plus medical visits, nearly 2,000 dental visits, and about 2,200 telemedicine appointments. All of this during a time when many providers had a decline in patient volume due to the pandemic.

The facilities mission is to establish a medical home so that the community can have medical care regardless of the ability to pay. The facility offers a safe, respectful, and loving place to seek health care.

Since opening, the facility has added a pediatric pod, hired a reginal site director, and a patient navigator. The facility partners with Region 10 Early Headstart and Headstart, Lifepath Systems, and One Heart McKinney. The facility works hard to inform the public through outreach with area ISD's, health systems, non-profit organizations, and area coalitions.

After touring this facility, I was in awe of the foresight put into this project. The project was built with room for expansion, which they have already taken advantage of. The aesthetics also create a welcoming environment. This facility is building relationships and offering less barriers to accessing health care. They offer a medical home where the whole patient can be treated and an environment that is supportive and caring. The facility also offers connections to other valuable resources.

I am thankful and honored that we have the Family Health Care on Virginia facility in McKinney.

	Currently, over 20 million Americans suffer from addition, with over 1.5 million of those estimated to live in Texas and that's during "normal times." During the pandemic, the number of addicted individuals skyrocketed. Recent news articles estimate that over 100,000 people nationwide died from drug overdoses during just 12 months of the pandemic.	
	Although the most recent headlines have garnered increasing attention on the issues of addiction, including a global opioid	

settlement recognizing the responsibility of some of the nation's largest drug manufacturers, substance abuse is not a new phenomenon.

Ten years ago, Shannon White established the GraceToChange Substance Abuse Treatment Center as a nonprofit, and she designed a program focused on meeting individuals where they were in their addiction journeys, whether abiding by court-mandated drug treatment or whether personal circumstances encouraged seeking help.

At its very core, the organization's mission is simple: to break the cycle of addiction for adolescents and adults by providing the tools, support, and hope for a lifetime of recovery. GraceToChange accomplishes this mission by offering intensive, tailored outpatient treatment in both individual and group sessions. For those who complete the program, GraceToChange offers the almost-unheard-of benefit of lifetime FREE weekly counseling as after-care. This additional benefit, which you won't find at other treatment centers, was developed through years of experience and witnessing the successes and failures of clients. Shannon and her team know clients continue learning and growing during their lifetimes of sobriety, and one key ingredient to success is the ability to create and maintain critical sober relationships with other group members. As an added benefit to the community, clients who are farther along in their recovery are able to mentor and encourage those who are newer to the program.

GraceToChange primarily helps an underserved population in our community: indigent and poverty-stricken substance abusers who are looking for a way out of addiction. GraceToChange is the ONLY adolescent provider and is 1 of only 3 adult providers that accepts county Behavioral Health/Medicaid funds within this county of one million residents. GraceToChange's success rate as a program has also drawn the attention of other members of our community whose family members have benefitted from its proven treatment results. GraceToChange's service area, both geographically and in a variety of populations, continues to grow. The organization now serves clients and their families throughout Collin County.

However, it's not just those in treatment and their families who

benefit from the GraceToChange program. Because outpatient treatment helps those who suffer from addiction stay out of jail, continue working, and ensure they remain contributing members of our community, local criminal justice professionals rely on Shannon and her team to:

* Help lower costs from incarceration (treatment is much cheaper than jail from a county budget perspective), saving tax dollars for Collin County residents

* Reduce the need for judges to hear recurring substance abuse cases if treatment is successfully concluded

* Boost success rates for treatment by offering after-care and mentorships

* Work with police and sheriff departments to help them handle calls that involve non-violent substance abusers

* Offer training in jails and in police departments

* Speak to at-risk high schoolers to emphasize the importance of staying sober

* Decrease the number of children removed from homes by CPS for parental drug-related accusations, if GraceToChange determines the charges to be either one-time occurrences or something that can be treated successfully without danger to the children

The staff at GraceToChange exhibit daily dedication, drawing upon life experiences and education that understand addiction behavior, to make a difference in a community that would be left adrift without help at a time when addiction rates are climbing and the need for services is growing. I nominate GraceToChange for this award because they work every day to achieve their motto: "Change A Life. Change A Community."

Please describe how the nominee has positively impacted Quality of Life in McKinney?	I am delighted to nominate SBG Hospitality for the Small Business of the Year award. SBG is the premiere event production and marketing company in North Texas, and we should be proud that it calls McKinney its home. For more than 5 years, SBG has brought the residents of our city together— and attracted tourists to our city—to enjoy festivals and other special affairs that highlight music, food, fellowship, and iconic locations throughout McKinney. But not only does it serve to entertain us, SBG also—and perhaps most importantly—gives back to its community with every event that it hosts.

One example of this is the McKinney Wine and Music Festival, which, since 2017 has become a beloved tradition. In 2021 alone, the festival welcomed more than 6,000 attendees and showcased 30 vineries, 14 bands, and 100 vendors. Having outgrown its original location at Adriatica, it moved to the beautiful Towne Lake Park, and took advantage of the waterside trails and expansive shade to allow for ample flow and comfortable seating for guests' enjoyment. Partnering with four unique nonprofit organizations—Hugs Café, The Love Life Foundation, Warrior's Keep, and the Treasured Vessels Foundation—SBG also donated more than \$4,100 from the event's proceeds. This money supports important initiatives that encourage the employment of adults with developmental needs, provide support to children and families, enhance the quality of life for veterans, and aid in the restoration and healing of trafficking survivors.

Another example is its McKinney Sip and Stroll Series, which began in 2020, as an innovative shift from the "typical festival" in light in COVID-19. In 2021, SBG hosted 5 events in this portfolio, including a margarita walk, and again welcomed more than 6,000 attendees. Held in downtown McKinney, these events increased sales and foot traffic to local stores when they needed sales-boosts the most, promoted the city as a tourist destination, and emphasized the importance of supporting local proprietors, all of which is extremely important in these uncertain economic times. As with all its events, SBG partnered with several nonprofits and with this series, donating more than \$8,700 of its proceeds for local initiatives. In 2022, SBG has four Sip and Stroll events planned in McKinney and will link arms with Hugs Café and the Alliance for Elite Youth Leadership in the coming year.

In addition to these illustrative events, SBG has also sponsored foot races, such as the annual Monster Dash and Shamrock Run. These events promote wellness while encouraging fun and creativity with costumes, pet parades, and the active engagement of children and families. In addition, all SBG events highlight local businesses, who through their partnerships, are encouraged to set up vendor tables and tents to display their specialties and impress attendees through engagement with their brands. SBG's professional promotion services, which include widespread use of social media and other cutting edge marketing tools, advances awareness of these local businesses and ultimately increases their sales.

SBG is family owned and operated and an active member of the McKinney Chamber of Commerce and McKinney Young Professionals. It should be selected for what it contributes to our city's entertainment culture—with several marquee events each year—but, also because it is dedicated to giving back and fostering connections with the local nonprofit sector—more than \$31,000 in nonprofit contributions from the two years of the Sip and Stroll Series alone. Having had to substantially pivot the way it plans for and logistically designs its events in the wake of COVID-19, SBG hasn't missed a beat in continuing to promote awareness of local nonprofit organization's missions, elevating the status of McKinney as the region's leading tourist destination, and helping to strengthen the business climate through its vendor and sponsor opportunities.
