

**RESOLUTION NO. 2017-02-\_\_\_\_ (R)**

**A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, IN SUPPORT OF THE APPLICATION BY MERRITT MCGOWAN MANOR, L.P. TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS (TDHCA) FOR TAX CREDITS FOR THE MERRITT MCGOWAN MANOR LOCATED AT 1200 N. TENNESSEE; MAKING FINDINGS RELATED TO THE SUBJECT AND DESIGNATING MERRITT MCGOWAN MANOR IS THE 2017 9% TAX CREDIT DEVELOPMENT THAT CONTRIBUTES MORE THAN ANY OTHER TO THE CONCERTED REVITALIZATION EFFORTS OF THE CITY OF MCKINNEY; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the Merritt McGowan Manor, L.P. is proposing to construct Merritt McGowan Manor, a 136 unit, affordable, multifamily development, located on the current site of Merritt Homes at 1200 N. Tennessee Street (the "Project") in the City of McKinney, Collin County, Texas (the "City"); and

**WHEREAS**, Merritt McGowan Manor, L.P. has provided notice to the City in accordance with Chapter 2306 of the Texas Government Code of its intent to file its application with the Texas Department of Housing and Community Affairs (the "TDHCA") for 9% tax credits for the development of the Project and has requested from the City issuance of a Resolution of Support of the Project as part of Merritt McGowan Manor's application to TDHCA; and

**WHEREAS**, City staff has reviewed the Project in accordance with the City of McKinney Low Income Housing Tax Credits Resolution Policy; and

**WHEREAS**, the City has had sufficient opportunity to obtain a response from Merritt McGowan Manor, L.P regarding any questions or concerns about the Project; and

**WHEREAS**, the City conducted a public hearing in accordance with Chapter 2306 of the Texas Government Code so that public comment may be made on the Project; and

**WHEREAS**, the City made findings designating Merritt McGowan Manor the 2017 9% tax credit development that contributes more than any other to the concerted revitalization efforts of the City of McKinney; and

**WHEREAS**, the City of McKinney understands the importance of the low income housing tax credits program and the ability of developers to invest in and construct affordable housing.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, COLLIN COUNTY, TEXAS, THAT:**

Section 1. The foregoing premises are incorporated herein by reference.

Section 2. After due consideration of the information provided by Merritt McGowan Manor, L.P. and public comment, the City of McKinney, acting through its governing body, supports the application submitted to the TDHCA for the Project and its proposed location within the City of McKinney.

Section 3. The City of McKinney's support of the Project is based on the following legislative findings: \_\_\_\_\_.
