MCKINNEY AIRPORT DEVELOPMENT CORPORATION

September 8, 2011

The McKinney Airport Development Corporation (MADC) Board met September 8, 2011 at 9:00 a.m. in the conference room at the MEDC offices 321 N. Central Expressway, McKinney, Texas 75069.

CALL TO ORDER

Executive Director: Ken Wiegand updated members on the Runway and FM 546 projects. Steve Gould reported on the status of the remote access program at the airport. Ken also reported on recent airport marketing promotions and that staff had registered for NBAA Schedulers and Dispatchers Conference in January 2012. Ken stated that he was on the City's Sustainability Committee and invited members to a community meeting held at Collin College (Central Park Campus) on September 17, 2011 at 9:00 a.m. regarding the draft Sustainability Plan.

Ken asked Member Fritz Mowery to update members on the Collin County Student Aviation Initiative (CCSAI).

Paul Cristina, P.E. with Kimley-Horn gave a progress update on the Airport Layout Plan (ALP). A board workshop (#2) will be held on October 13, 2011 at the regular monthly board meeting.
