HISTORIC PRESERVATION ADVISORY BOARD MEETING

DECEMBER 2, 2010

Chairperson McKissick called the meeting to order.

Chairperson McKissick continued the agenda with the Consent Item. On a motion by Vice-Chairperson Susan Germann, seconded by Board Member Hubbard, the Board voted 5-0 to approve the following Consent Item:

Conduct a Public Hearing to Consider/Discuss/Act on the Request by David and Mercedes David for Approval to Receive a Historic Marker for the House Located at 206 South Benge Street.
