The McKinney Convention and Visitors Bureau Board met in regular session at the MCVB Conference Room, 200 W. Virginia, McKinney, Texas on January 22, 2013 at 7:30 a.m.

Vice Chair Gardner called the MCVB board meeting to order at 7:33 a.m. and introduced new board member Sharon Dill as well as recognized guests.

Minutes of the McKinney Convention & Visitors Bureau Meeting of December 4, 2012. Board members unanimously approved the motion by Board member Linda Fogg, seconded by Board member Shqiprim "Doc" Vranici, to approve the minutes from the December 4, 2012 MCVB board meeting.

13-069 Committee Reports Finance, Marketing & PR, and Development.

Finance – Director of city finance Rodney Rhodes provided overview of how funding for CVB budget works in relation to hotel/motel tax fund. Rhodes advised that excess hotel tax that is collected is moved into a hotel/motel fund balance and in order to pull from the fund balance, it must be approved by city council.

Marketing & PR - Board member Gardner reported that the marketing

committee met to discuss ideas of the MCVB creating a rack card until a new visitor's guide/marketing campaign is created. Interim Executive Director Guerra advised board members that the MCVB staff worked with a film crew from HGTV while they were in McKinney filming for a real estate program. Board member Gardner and City Communications Director Good updated board members on co-op marketing efforts with city communications. Good also advised board members that a press release for both MEDC & MCVB will be sent to advise the media of the launch of their new websites. Director Gardner advised board members that the marketing committee had an open position, board member McEntire also advised there was an open position for the finance committee. Director Fogg received the vote for the marketing committee and director Vranici received the vote for the finance committee.

Development – Board member Vranici advised board members the development committee met last week. Topics discussed were: the criteria for the Chamber award selection; committee will meet next week to discuss the MCVB bylaws and possible revisions; and the MCVB will move under city IT at the end of August/early September.
