Guerra advised board members that the CVB will continue to focus on the Social, Military, Educational, Religious, & Fraternal (SMERF) markets.

MCVB Director's Report: Executive Director Guerra highlighted MCVB accomplishments for the month of February and asked board members if they had any questions from the report she provided to them via e-mail earlier in the week. Guerra highlighted the MCVB website analytics, Social Media results and hotel revenue that staff assisted in securing.

MCVB Development Committee Report. Committee Chair Doc Vranici advised board members that development committee met and finalized the Policy & Procedure manual for the MCVB as well as the Quick Reference guide for new MCVB board members. Vranici also advised board members that the Made In McKinney retail store would sell, on a cash basis only, Krewe of Barkus T-shirts and the profits from those

sales would be spilt 3 ways between Main Street, the MCVB and the Made in McKinney retail store with store owner profits going to the SPCA.

MCVB Finance Committee Report. Committee Chair Steve Conlin updated board members on the MCVB finance status stating that Rodney Rhoades, City of McKinney Finance Director has advised the finance committee that the CVB needed to draw down from the fund balance over the next three years.

MCVB Marketing/PR Committee Report. Committee Chair Dill advised board members that the committee agreed to allow the CVB to purchase BatchGeo.com which is a demographic and geographic tracking website. Dill also reviewed the advertising buys that the CVB purchased for spring publication.

City of McKinney – Finance Budget Manager Mark Holloway advised board members that the planning for FY 2014-2015 budget will begin in mid-March and stated that preliminary budgets will be ready in April.

Chamber of Commerce and MPAC/Main Street - MCVB Executive Director advised board members that the Chamber Award Banquet will take place on February 28, 2014. Guerra also advised board members of the upcoming events taking place in Historic Downtown McKinney: 4 Funny Females, Krewe of Barkus, Beatlemania, and Arts in Bloom.
