

**RESOLUTION NO. 2021-02-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE CATHOLIC CHARITIES OF DALLAS, INC., AS THE CITY'S SUBRECIPIENT UNDER ROUND TWO OF COVID-19 FUNDING THROUGH THE DEPARTMENT OF THE TREASURY EMERGENCY RENTAL ASSISTANCE PROGRAM (ERAP) AND APPROVING A RELATED CONTRACT WITH CATHOLIC CHARITIES OF DALAS, INC., TO PROVIDE THIRD PARTY ADMINISTRATOR SERVICES; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City of McKinney has amended its Annual 2020-2021 Budget to include Round Two of COVID-19 Funding from the Department of the Treasury, through Collin County, to provide emergency rental and utility assistance to McKinney residents, in the amount of \$5,486,423; and

**WHEREAS**, the City, through its proposed subrecipient, Catholic Charities of Dallas, Inc., ("Catholic Charities"), will implement the Emergency Rental Assistance Program (ERAP) to provide rental and utility assistance to prevent eligible residents from eviction and homelessness.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The City wishes to implement the Emergency Rental Assistance Program (ERAP) to assist McKinney residents with rental and utility assistance.
- Section 2. The City Council of the City of McKinney, Texas ("City Council") hereby approves Catholic Charities as the City's subrecipient under Round Two of the Department of the Treasury ERAP involving the distribution and expenditure of up to \$5,486,423 in ERAP funding.
- Section 3. The City Council hereby approves the Subrecipient Grant Agreement between the City of McKinney and Catholic Charities of Dallas, Inc., in an amount of up to \$438,914 for the performance of Third-Party Administrator Services to administer and facilitate the City's participation in the ERAP.
- Section 4. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
