

CITY COUNCIL REGULAR MEETING

SEPTEMBER 20, 2022

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, September 20, 2022, at 6:00 p.m.

Council unanimously approved the motion by Council Member Charlie Philips, seconded by Council Member Patrick Cloutier, to appoint Steve Wilson to the Capital Improvement Advisory Committee (CIAC), as a Regular Member. The appointment is a full 2-year term, effective October 1, 2022, until September 30, 2024.

Mayor Fuller called for Public Comments regarding matters not on the agenda, at which time there were no requests to address the City Council.

Mayor Fuller called for Council & Manager Comments.

Council Member Justin Beller stated he joined Dr. Feltus and Mr. Grimes at an H-E-B. event, and it made him excited for their future in McKinney. On the past Saturday were celebrations of Hispanic Heritage Month, with the Parks department planning a great event and lots of people attended, and he is excited for what that can grow into hearkening back to celebrations we've had in the past, for fiestas and September 16th celebrations. Late Gilda Garcia Garza was honored with the renaming of the aquatic center in her name, her daughter, Andrea did an excellent job of honoring Gilda and her entire family. The kids at Caldwell Elementary school are doing a fundraiser for kindness by trying to teach acts of kindness. They're raising money for field trips, programs, and outdoor courtyard improvements. Some of the students recently attended a special event with Mayor Fuller and will be at other places across the town. This is a good opportunity to teach kids what it means to be part of a community. Council Member Beller attended on this past Sunday Charles Wattley's 39th year celebration as pastor of St. Mark's Church at the corner of Elm and McDonald streets. Council Member Beller stated Dr. Jim Wilson passed away last week at the age of ninety-one (91) years old. He was a 5th generation Collin County resident, graduate of Austin College, served in the Navy, and he practiced medicine in McKinney since 1967 until he retired. He was named the Chamber of Commerce Citizen a Year in 2010, and he had three kids - two of them are excellent citizens of the city of McKinney. Council Member Beller extended prayers to their family.

Council Member Franklin attended the dedication on Saturday for Gilda Garza along with several Council Members and the Mayor. They gave heartfelt speeches about their time with Gilda. Council Member Franklin stated one of the most one of the things he really missed about Gilda was her famous smile. She was always working and always involved always. She did so much for her district for the city of McKinney. Council Member Franklin thanked Ken Sipiara, outgoing Member of the McKinney Economic Development Corporation (MEDC), for his service and leadership.

Council Member Cloutier encouraged the Leadership McKinney class to visit the Gilda Garza Aquatic Center, acknowledging the vision, dedication and hard work it took to build the recreation facilities and help develop that area. Council Member Cloutier recognized and thanked several outgoing boards and commissions members for their

service to the city: Ken Sipiora (MEDC), Rick Glew and Jackie Brewer (McKinney Community Development Corporation), Kip Dixon (Parks, Recreation & Open Space Advisory Board), and Molly Brewer (McKinney Arts Commission), each who served more than ten (10) years on various boards, going above and beyond, and each leaving their boards better than they found them, building relationships and being a part of great things in our city.

Council Member Charlie Philips commented on the recent college game in which the University of Texas nearly upset the top-ranked University of Alabama, stating that McKinney High School graduate Katie McGill is a cheerleader for the University of Texas. Council Member Philips recognized high school quarterbacks: Keldric Luster of McKinney High School was recently named the Dallas Morning News Offensive Player of the North Texas region. Council Member Philips encouraged everyone to take opportunity watch him and Colin Hitchcock of McKinney North High School play. Council Member Philips extended well wishes for a full recovery to police officers Mike Davis and John Harris who were involved in an accident. Council Member Philips stated he recently met with Officer Harris and another Officer Haley Hibbs for a traffic violation, and their were very respectful and courteous and did everything right, which is why the Council supports and thanks the police in our city.

Council Member Feltus thanked the police department for working on the recent case of vandalism at Stonebridge Methodist Church and thanked the community for its outpouring of support for efforts to make sure that McKinney is loving and inclusive and tolerant of all. Council Member Feltus stated a group will meet during this week to create a campaign that we all should be able to join and say we are not going to stand for racism in this community. Council Member Feltus expressed excitement about the store H-E-B coming to the area, stating they had an incredible dining service event with a lot of interesting foods, her favorite being the pork belly wrapped in smoked cotton candy. They featured some of their premier products that they're bringing to the area, and they've already gotten involved in this community, being a great support to several local non-profit organizations.

City Manager Paul Grimes made these announcements:

- The Oktoberfest event will be this coming weekend, Friday, Saturday, and Sunday. Council Member Cloutier will be leading the keg tapping activity. City Manager Grimes reminded the public purchases can be made directly from vendors instead of through tickets and encouraged everyone to bring their credit or debit cards instead of cash.

Mayor Fuller was unable to attend the H-E-B event as he was at an event in Plano, Texas, celebrating Rick Grady, who received an award that is now named in his honor, recognizing service to people with disabilities. Mayor Fuller acknowledged the event honoring Gilda Garza as well as Leia Hunt and her program supporting those impacted by childhood cancer. Mayor Fuller encouraged the public to support the organization Leia's Kids for the upcoming North Texas Giving Day. Mayor Fuller thanked Ken Sipiora, Jackie Brewer, Rick Glew, Kip Dixon, and Molly Brewer for service to the respective boards they served.
