

CITY COUNCIL REGULAR MEETING

JUNE 5, 2012

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on June 5, 2012 at 6:00 p.m.

12-386 Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on an Ordinance Vacating Approximately 0.016 Acres Located on the East Side of Coit Road South of Westridge Blvd in Exchange for the Dedication of 0.021 Acres Located on the East Side of Coit Road South of Westridge Blvd, and Accompanying Ordinance. Senior Engineer Dan Heischman stated that this item regards a land swap that will abandon approximately 0.016 acres located on the east side of Coit Road south of Westridge Boulevard. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Council member Harris, seconded by Council member Brooks, to close the public hearing and approve the Ordinance vacating approximately 0.016 acres located on the east side of Coit Road south of Westridge Blvd in exchange for the dedication of 0.021 acres located on the east side of Coit Road South of Westridge Boulevard with the following conditions: the City of McKinney reserves an exclusive, utility easement within the entirety of the abandoned right-of-way and the owner of the adjacent tract dedicate 0.021 acres of right-of-way along the east side of Coit Road as shown on Exhibit B. 12-088Z2 Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by Rick Jones Company, L.L.C., on Behalf of VCIM Partners, L.P., for Approval of a Request to Rezone Approximately 1.08 Acres from "PD" - Planned Development District, "REC" - Regional Employment Center Overlay District, and "CC" - Corridor Commercial

Senior Planner Michael Quint stated that the applicant is proposing to rezone approximately 1.08 acres of land, located on the north side of State Highway 121 (Sam Rayburn Tollway) and approximately 1,960 feet east of Alma Road from "PD" - Planned Development District, "REC" - Regional Employment Center Overlay District, and "CC" - Corridor Commercial Overlay District to "PD" - Planned Development District, "REC" - Regional Employment Center Overlay District, and "CC" - Corridor Commercial Overlay District, to allow for a canine boarding facility with outside runs. Staff is recommending approval as conditioned in the Staff Report. Applicant, Mr. Brian Baca, 2600 Eldorado Parkway, Suite 110, McKinney, was available for questions from Council and there were none. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Council member Harris, seconded by Council member Day, to close the Public Hearing and approve the Ordinance rezoning approximately 1.08 acres from "PD" - Planned Development District, "REC" - Regional Employment Center Overlay District, and "CC" - Corridor Commercial Overlay District to "PD" - Planned Development District, "REC" - Regional Employment Center Overlay District, and "CC" - Corridor Commercial Overlay District, to allow for a Canine Boarding Facility with outside runs, located on the north side of State Highway 121 (Sam Rayburn Tollway) and approximately 1,960 feet east of Alma Road, with the following special ordinance provisions: use and development of the subject property shall conform to the regulations of "PD" - Planned Development District Ordinance No. 2004-12-123, except as follows: an

- 12-387** Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Resolution Adopting the On-Street Bicycle Master Plan. Transportation Engineering Manager Gary Graham presented the On-Street Bicycle Master Plan. Mr. Graham stated that this is the culmination of a year and a half of work with City Staff and the consultant. The proposed master plan addresses the following: Integrates bike routes into the current Hike and Bike Trail Master Plan thereby filling in the missing links in the system, includes recommendations regarding the implementation and completion of the various elements, recommends facility treatments to increase safety of riders, recommends policies and programs for education and public awareness. Adoption of this plan will not obligate

the Council to implement any of the bike plan elements. The later phases will be completed as funds are available and as roadways are constructed. The largest expense is associated with the additional pavement width to accommodate a bike lane. A majority of the remaining arterial roadways will be constructed by developers and the components of this master plan will be completed with those projects. Mayor Loughmiller called for public comment.

Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Brooks, to close the Public Hearing. Mr. Graham stated that to retrofit the existing portion of the City would cost \$1.6 million. For the future arterials that have not been constructed yet, there would be an additional \$15 million costs associated for the plan or approximately 3% added on to the construction of these future arterials. Council member Brooks stated that this is a quality of life issue and this will not raise taxes. Council member Ricchi stated that he is concerned with the safety function of this plan. Mayor Loughmiller stated that the current Council has not passed any annual budget that required a tax increase, is balanced with revenues and expenditures, and we increased the reserve funds by over \$7 million. Mr. Loughmiller stated that there are things we can do as a community to help with the health and safety of our citizens without negatively impacting us from a budget standpoint. Council approved the motion by Council member Brooks, seconded by Council member Harris, to approve the Resolution adopting the On-Street Bicycle Master Plan with a vote of 5-1-0, Council member Ricchi

voting against. Caption reads as follows:

- 12-352** Mayor Loughmiller called for Consideration/Discussion/Action on Approval of a Letter of Intent with Champ Hospitality and Beck Development in Regards to the Gateway Hotel and Conference Center. City Manager Gray stated that he recommended that the Council go into Executive Session to confer with the attorney regarding this matter.

Mayor Loughmiller recessed the meeting into executive session at 7:35 p.m. per Texas Government Code Section 551.071 (2). Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed), Section 551.071 (1) (A). Litigation / Anticipated Litigation, Section 551.074 Personnel Matters, Section 551.072 Discuss Real Property, and Section 551.087 Discuss Economic Development Matter as listed on the posted agenda. Mayor Loughmiller recessed to the open session at 8:05 p.m.

- 12-352** Mayor Loughmiller called back for Consideration/Discussion/Action on Approval of a Letter of Intent with Champ Hospitality and Beck Development in Regards to the Gateway Hotel and Conference Center. City Manager Jason Gray stated that several weeks ago the Council authorized him to begin working with the Beck Development and Champ Hospitality in regards to the Gateway Hotel and Conference Center. The Letter of Intent allows us to move forward with this project in a manner in which it identifies the major deal points of the development agreement that will come next. What this allows is to begin to restructure the plans to remediate the existing structure at the Gateway site, and prepare ourselves for construction on the site. Council unanimously approved the motion by Council member Brooks, seconded by Mayor Pro-Tem Ussery,

to to approve the Letter of Intent with Champ Hospitality and Beck Development in regards to the Gateway Hotel and Conference Center subject to the addition of the trigger language that would allow a conclusion to the investment and to clarify the intent that there would not be a cap on either party's return in the event of a sale.

Mayor Loughmiller called for Council and Manager Comments.

Council member Harris complimented the City Manager on his unique approach that he presented at a county wide meeting for a proposal for aviation related projects at the airport. Mr. Harris stated that the Police and Fire Meet and Confer agreements are sending a strong message that McKinney is a good place to work. We care about the citizens, and it is the first step in creating a good culture. Mr. Harris stated that McKinney Police Officer Donny Williams has an incredible video out on UTube that demonstrates what a phenominal job he can do handling a motorcycle. He stated that the Holly Cavanaugh event was a fun event that drew a large crowd to the downtown square as well as Bike the Bricks that was held on Friday night. The Memorial Day Ceremony at Pecan Grove Cemetary was the best he had ever seen. Mr. Harris recognized McKinney resident Bree Hafen who is a contestant on So You Think You Can Dance. Mr. Harris stated that the City of McKinney has had some incredible public relations opportunities over a short period of time which is a small indication of some great things to come to this area.

Council member Brooks stated that a lot of good work has been done by the City and when you stick with it and keep plowing ahead you make it to the finish line. After a year and half of work the Bike Plan was approved tonight and we took a big step tonight on getting the Gateway Hotel/Conference Center. Mr. Brooks stated that it is an honor to serve with this Council.

Mayor Pro-Tem Ussery thanked staff for what they do. Mr. Ussery complimented the unsung heroes from the Public Works Department who set up the downtown area for the Friday night Bike the Bricks race and had it taken down in time for the parade on Saturday morning without a hitch. The City should be proud of what they do tirelessly. Mr. Ussery recognized former Planning Director Jennifer Cox for her ten years with the

City, who put forth a sincere effort in her job and McKinney is better for her efforts. Mr. Ussery thanked Council for giving him another year as Mayor Pro-Tem.

Council member Ricchi stated that he had the pleasure and sadness to drive his son 1,100 miles away to play summer baseball. During the drive, his son commented that McKinney is a place where he wants to be because he has seen a lot of other places on the road. This is a wonderful community because of the people who came before and sat on this Council. Mr. Ricchi thanked City Manager Gray on enduring an amazing first year, what he has done, and what he is going to continue to do. It is not an easy job and that is why we picked you. Mr. Ricchi stated that Mayor Pro-Tem Ussery does an outstanding job representing our City in the Mayor's absence in so many different ways. Mr. Ricchi commented that we all work together, not necessarily agreeing, but we do come together to get to the same place. Mr. Ricchi complimented Mayor Loughmiller on his representation of the City each and every day in so many different ways around the community, state and nationally. Mr. Ricchi recognized Ms. Cox for her great service in the Planning Department while she was with the City.

Council member Day stated that he appreciates his colleagues and the City Manager. "Sometimes we strongly disagree, but we come to the final decision that is the right decision and I appreciate everyone of you."

Mayor Loughmiller commented that he had a good meeting today with Money Magazine about what changes and improvements have happened since 2009 and provided an update on a number of initiatives that we have been working on over the last few years. Mr. Loughmiller stated that last year on "So You Think You Can Dance" there was another student from Boyd High School who was in the top 40 but during the competition in Hollywood she was sick and fell off the stage. The show has given her a pass to make it to the top contestants this year. There is another Boyd High School student who was given a scholarship to perform on Broadway. "It is amazing how much talent we have in this City." Mr. Loughmiller stated that he will be in Austin tomorrow and he will be meeting with the staff from the Governor's office to discuss economic development projects in McKinney. Mr. Loughmiller announced that the City is now accepting applications for positions on the various Boards and Commissions. The deadline for filing an application is June 29th. Any current member of a board whose

term is up this year will need to reapply to be considered for reappointment. Members can only serve two consecutive terms on a Board. Interviews will be conducted from July 16th through August 1st. Board appointments will be made at the August 27th Special Meeting.

City Manager Gray stated that he appreciates the Council's comments on his work. Mr. Gray recognized the group from the development team who has helped worked through this process. He stated that they approached this project in a true partnership fashion. The group from Beck and Champ Hospitality have worked through a variety of different issues that have come up. We have come up with a very workable Letter of Intent and everyone is excited to get started. We will start on a Development Agreement that will ensure that we are going to have a high quality conference center and hotel to anchor the entire Gateway site.

Mayor Loughmiller called for Citizen Comments and there was none.

Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Ricchi, to adjourn. Mayor Loughmiller adjourned the meeting at 8:30 p.m.
