




City of McKinney Proclamation

- WHEREAS,** Captain Barry L. Brown was born and raised in Baton Rouge, Louisiana and graduated from Southeastern Louisiana University with a Bachelor of Arts Degree in Business Administration/Finance in 1979; and
- WHEREAS,** Captain Barry L. Brown was commissioned an Ensign in the U.S. Navy Reserve through the Direct Commissioning Program in March 1988 and served in the Naval Reserves for over 28 years; and
- WHEREAS,** Captain Barry L. Brown served as Commanding Officer, DLA Disposal Remediation Team Six, Jacksonville, Florida; Commanding Officer, Voluntary Training Unit 7070G, Fort Worth, Texas; Chief Staff Officer, Senior Plans Officer and Assistant to the Executive Director, Navy Supply Systems Command Global Logistics Support Headquarters, Norfolk, Virginia; Assistant to the Executive Director, Defense Logistics Agency, Fort Belvoir, Virginia; Executive Officer, Navy Expeditionary Logistics Response Center, Williamsburg, Virginia; Executive Officer, Navy Petroleum Office Detachment 110, Houston, Texas; and
- WHEREAS,** Captain Barry L. Brown was first mobilized in 1990 in support of Operations Desert Shield/Desert Storm while assigned to Military Sealift Command Office Houston, Texas; was mobilized again in 2006 and deployed as Operations Officer, NAVELSG Forward Headquarters, Camp Arifjan, Kuwait, in support of Operation Iraqi Freedom and Operation Enduring Freedom; and was mobilized a third time in 2010 as Assistant Chief of Staff-Navy for Joint Logistics Command Haiti in Port au Prince, Haiti, in support of Operation Unified Response which provided humanitarian assistance and disaster recovery from the devastating earthquake in that country; and
- WHEREAS,** Captain Barry L. Brown has spent over 34 years in commercial banking and is President of the Dallas Market for Texas Bank and Trust; and
- WHEREAS,** Captain Barry L. Brown's decorations include the Meritorious Service Medal, two Joint Service Commendation Medals, Navy and Marine Corps Commendation Medal, three Navy and Marine Corps Achievement Medals, the Global War on Terrorism Expeditionary Medal and various campaign and unit awards; and
- WHEREAS,** Captain Barry Brown has given back to his community through community service as the current Chairman of the McKinney Armed Services Memorial Board, on the Board of Directors, USO of South Texas, Board of Advisors, College of Business at Texas A&M University Corpus Christi, Dallas Council of the Navy League of the United States, McKinney VFW Post 2150 Board of Directors, and Board of Directors – Kiwanis Club of Corpus Christi.


