

## **CITY COUNCIL WORK SESSION**

**OCTOBER 6, 2020**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas on Tuesday, October 6 at 3:30 p.m.

There were approximately two (2) members of the public present.

Mayor Fuller called the meeting to order at 3:32 p.m. upon determining a quorum of the City Council was present.

Mayor Fuller called for public comments on agenda items. There were none.

Mayor Fuller called for the discussion of the agenda items to be presented at the City Council Regular Meeting of Tuesday, October 6, 2020, at 6:00 p.m.

Director of Engineering Gary Graham spoke regarding agenda item # 20-0865 (Consider/Discuss/Act on a Resolution Supporting a US 380 Freeway Alignment

Generally Between Future Ridge Roas and Community Avenue Related to the Texas Department of Transportation US 380 Collin County Feasibility Study).

Mayor Fuller requested that items 19-0010M8, 19-0010M9, 19-0010M10, 19-001M11 be changed to reflect a Public Hearing date of December 1, 2020 for the items.

Mayor Fuller called for the following Work Session Agenda items, with no action taken by City Council:

Mayor Fuller called for Council Liaison updates regarding the McKinney Boards and Commissions.

Mayor Pro Tem Rogers updated the Council on the meeting of the Board of Adjustments that he attended. The Mayor Pro Tem compared the meeting to that of a Court Room in that people were getting sworn in, Board members were giving testimonies, there were cross-examinations, and there were multiple attorneys present. The Mayor Pro Tem stated that afterwards he has more appreciation for this Board and that they made two (2) good decisions during the meeting. The Mayor Pro Tem thanked the Board and thanked Rick Herzberger (Chief Building Official) for his work.

Council Member Franklin attended the Visit McKinney meeting and learned about Monarch Butterflies taught by Martha Cavazos-Fipps (Environmental Education Coordinator). Council Member Franklin informed the Council that McKinney is a sponsor City that is along the migration route of the Monarch Butterfly. Monarch Butterflies have lost 90 percent of their population over the last twenty (20) years.
