Mayor Loughmiller called for Consideration/Discussion/Action on a 14-749 Resolution Approving the McKinney Housing Authority (MHA) Request for City Funding for Newsome Homes Redevelopment and Authorization for the Interim City Manager to Enter into a Chapter 393 Loan Agreement Between the City of McKinney and the McKinney Housing Authority. Community Services Administrator Shirletta Best stated that on July 14, 2014, a request was presented to the City Council for a portion of the cost for the Newsome Homes redevelopment project. The McKinney Housing Authority (MHA) is requesting city funding and fee credits for the redevelopment of Newsome Homes. Council directed the developer to find cost-savings within the budget. The developer has presented a new request that reflects \$174,575 reduction from the original request. Staff was asked to present the city financing structure that would minimize impact to the general fund and which would be a Chapter 393 of the Local Government Code that would allow the city to provide a lowinterest revolving loan for a portion of the request and include terms that would be repaid over a 20-year period. This will allow for repayment of the loan to be reserved for future MHA housing redevelopment projects. Interim City Manager Tom Muehlenbeck stated that a Chapter 393 differs from a Chapter 380 agreement in the type of projects that can be covered. Mr. Muehlenbeck noted that there is an item in the 2015

budget for an estimated \$300,000 for infrastructure. At this time, Staff has been unable to get an exact cost of the infrastructure from the MHA. Council unanimously approved the motion by Council member Roger Harris, seconded by Council member Randy P. Pogue, to approve a Resolution Approving the McKinney Housing Authority (MHA) Request for City Funding for Newsome Homes Redevelopment and Authorization for the Interim City Manager to Enter into a Chapter 393 Loan Agreement Between the City of McKinney and the McKinney Housing Authority. 14-752 Mayor Loughmiller called for Discussion the on Investigation/Feasibility/Development Plan Establishment for the Proposed Collide Village (Innovation Village) a +/- 9.2 acre Tract of Land with Respect to a Potential Development Agreement. Interim Assistant City Manager Barry Shelton stated that the presentation tonight by Jason Adams and the Palladium is the conclusion of the 120 day exclusive negotiation period that was granted by the City Council. Mr. Adams and his Palladium team (Palladium and Studio 2547) presented their development proposal and plan. Mr. Adams has contracted with Catalyst Commercial (Catalyst) for market analysis, economic impact and return on investment (ROI) estimates related to the proposed development program and a finalized development agreement. Mr. Jason Adams, Mr. Tom Huth, and Mr. Mathew Peterson presented the implementation of the project. Mr. Huth stated that the development team will be the owner and the project is estimated to cost between \$75-\$80 million. Mr. Huth stated that included in the estimated \$75-\$80 million, the City would put the roads through the development to have access with an estimated allocation of \$2-\$4 million as part of the cost along with providing utilities. There is also an allocation of \$1-\$1.5 million for the park which includes an amphitheater and water feature. The structured parking will cost approximately \$6,000-\$8,000 per space. Mr. Shelton stated that the City and McKinney Economic Development Corporation have contracted with Catalyst Commercial to do a market analysis to understand the absorption rates and the feasibility of building this development and if it will be successful. We do have preliminary numbers back on the return on investment but Staff needs additional time to evaluate the assumptions and build in return based on the completion of the phases. We will then be able to plug in abatements, fee waivers, and other incentives to understand if it is a 5-year or 10-year return on investment. If Council gives us direction to move forward, we will bring back a program for offering incentives for this development. Mayor Loughmiller stated that he would like to move forward with more details in what the partnership or incentives look like as it pertains to return on investment.

Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing a Contract with Law Enforcement Leadership and Management Consulting, LLC for Services as the Interim Police Chief. Deputy City Manager Jose Madrigal stated that the contract before Council outlines the roles and duties of the Interim Police Chief, Mr. David James. Staff will conduct a national search for a new Police Chief and anticipates it will take 6 to 9 months to complete. In the meantime, an Interim Police Chief will serve in the capacity while we conduct the search. Mr. James comes to the city with over 37 years of law enforcement experience, 22 years as a Captain at the Dallas Police Department, and the last 15 years as the Police Chief for the City of Carrollton. Council unanimously approved the motion by Council

member Harris, seconded by Council member to approve a Resolution Authorizing a Contract with Law Enforcement Leadership and Management Consulting, LLC for Services as the Interim Police Chief. Caption reads as follows:

Director of Engineering Mark Hines stated that there is a proposed development going in at the corner of Wilmeth and future Ridge Road. As part of that development, they need to extend sewer service to that tract. If they are not able to come to an agreement with property owners, the city will proceed with condemnation. Staff is hopeful that does not happen but are asking Council for permission to do so if it becomes necessary. Mr. Hines notes that staff will do everything to come to an equitable agreement. Council unanimously approved the motion by Council member Kever, seconded by Council member Pogue, to approve a Resolution authorizing the use of the power of eminent domain to acquire all necessary easements from property owners, generally indicated on the attached property locator map, for the construction of utility lines generally known as Stover Creek Sanitary Sewer for the construction of utility lines from approximately 500 feet northwest of University Drive (US 380) continuing north to the intersection of Wilmeth Road and CR 161 (Future Ridge Road). Mayor Pro Tem Ussery and Council member Ricchi stepped down on the following item.

14-747 Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Resolution Approving the 2014-2015 Community Development Block Grant Annual Action Plan. Community Services Administrator Shirletta Best stated that the Community Grants Advisory Commission held two public hearings as well as review of CDBG city-funded programs and meetings with interested organizations who made application for funding resources. At this time we have received one public comment from Julie Smith who supported the redevelopment of Newsome Homes. Annual Action Plan will be submitted to the U.S. Department of Housing and Urban Development for approval. The funds will be available beginning October 1, 2014 through September 30, 2015. The proposed funding includes: CASA of Collin County, Collin County Committee on Aging, Communities in Schools -Caldwell Elementary, Community Dental Care, Community Lifeline Center, Health Services of North Texas, Maurice Barnett Wellness Center, McKinney Housing Authority, North Collin County Habitat for Humanity, The Salvation Army, McKinney Corps

The Samaritan Inn, Housing Rehabilitation Program, Non-Public Services/ Economic Development, and Grant Administration. majority of CDBG funds are used in the census tracts that have low to moderate income areas. The City monitors the funds through compliance and the agencies must have a contract agreement with the City. Along with the requirements under the U.S. Department of Housing and Urban Development as well as other requirements which include Davis Bacon, environmental requirements, and requirements. Every five years the City is required to have a Housing and Consolidated Plan that includes input from the citizens. Loughmiller requested that the Council be notified if the Housing and Community Development Department receives any mandates from Washington regarding requirements related to eligibility of the CDBG plan. Mayor Loughmiller called for public comment and there were none. Council approved the motion made by Council member Kever, seconded by Council member Harris, to close the public hearing and approve а Resolution approving the 2014-2015 Community Development Block Grant Annual Action Plan with a vote of 5-0-2, Mayor Pro Tem Ussery and Council member Ricchi abstaining. Caption reads as follows:

Mayor Pro Tem Ussery and Council member Ricchi returned to the dais.

14-748 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Confirming No Objection to the McKinney Housing Authority's Application for a Choice Neighborhood Planning Grant through the Department of Housing and Urban Development. Community Services Administrator Shirletta Best stated that this item is to approve a resolution confirming the City of McKinney's support for MHA's application for a

Choice Neighborhood Planning Grant through HUD with modernization of buildings and public improvement included in the surrounding communities as well as schools and neighborhoods east of Tennessee Street and other distressed areas. The surroundings would include a variety of partners as schools, businesses, churches, and residents involved in the process. Ms. Best stated that there is no City funding support that would be a part of this package but the opportunity to be able to leverage and engage resources as it relates to partnership and outreach. The only funding that they could apply for would be CDBG funding where they would have to apply and go through the citizen process to determine if their project met the requirements for CDBG funding. Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by Spiars Engineering, Inc., on Behalf of Ysis Partners, L.P., for Approval of a Request to Rezone Fewer than 17 Acres from "PD" -Planned Development District to "PD" - Planned Development District, Generally to Modify the Development Standards, Located on the South Side of Bloomdale Road and on the West Side of Lake Forest Drive, and Accompanying Ordinance. Director of Planning Michael Quint stated that the applicant is requesting rezoning of approximately 16 acres of land from commercial uses to residential uses. This is contrary to Council's stated goals of preserving the non-residential tax base. In addition, the applicant is requesting special ordinance provisions that are not in conformance with the Comprehensive Plan regarding the densities. The Comprehensive Plan calls for a density of 3.2 dwelling units per acre. The applicant is proposing close to four units per acre. Staff is recommending denial. Mr. Quint stated that there is an opportunity to consolidate all commercial and retail uses on one corner which makes it more pedestrian-friendly. Mr. Quint stated that it has been to P&Z a number of times and the applicant did not meet the median lot size and could not meet the Comprehensive Plan densities in lot sizes. The Planning and Zoning Commission was supportive of this request and recommended approval. Mr. Quint stated that unless the developer is building houses nearing the \$400,000 value, the estimated taxes on that property will not pay for the City services required. Applicant, Mr. Steve Lenart, 520 Central Parkway East, Suite 104, Plano, stated that the current property owners had no success marketing the property as a commercial use for the past seven to eight years. He felt the proposed development would be successful on the site. Council approved the motion by Mayor Pro Tem Ussery and seconded by Council member Kever to close the public hearing with a vote of 6-0-1, Council member Pogue abstaining. Council members expressed concern over the size of the property being able to accommodate a large-scale commercial development as well as the challenges with sanitary sewer and water service to the property. Council approved the motion by Council member Kever, seconded by Mayor Loughmiller, to deny the rezoning request located on the south side of Bloomdale Road and on the West Side of Lake Forest Drive with a vote of 4-2-1, Mayor Pro Tem Ussery and Council member Day voting against and Council member Pogue abstaining.

Council member Pogue returned to the dais.

Mayor Loughmiller called for Consideration/Discussion/Action on Fiscal Year 2014-15 Proposed Tax Rate, Take Record Vote and Set Public Hearing and Adoption Dates. Chief Financial Officer Rodney Rhoades stated that the proposed tax rate for fiscal year 2015 is \$0.5830 which is one quarter cent lower than the tax rate that was adopted \$0.5855 tax rate for fiscal year. Because the proposed tax rate exceeds the effective tax rate, we do have to call for a record vote of the proposed tax rate and set two public hearing dates. Those dates would be scheduled for August 19, 2014 at 6:00 p.m. and September 2, 2014 at 6:00 p.m. The adoption date of September 16. Mayor Loughmiller stated that the proposed tax rate is higher than the effective tax rate because the effective tax rate is based on the ad valorem value set on property by the appraisal district. From a tax rate standpoint as it relates to the city we are actually lowering the tax rate by a quarter cent but it will still be higher than the effective tax rate based on those values. Mr. Rhoades stated that the property values increased by approximately \$1.5 billion over 2014 which equates to about a 12.9% increase The average home value increased from \$217,000 to \$240,000. Interim City Manager Muehlenbeck stated that the tax rate set tonight is the maximum that the tax rate can be. Council unanimously approved the motion by Mayor

Loughmiller, seconded by Council member Harris, that the City of McKinney propose to adopt a total Tax Rate of \$0.58300, which is higher than the Fiscal Year 2015 Effective Tax Rate of \$0.538235, and call for two public hearings; the first public hearing to be held on August 19, 2014 at 6:00 p.m. and the second public hearing to be held on September 2, 2014 at 6:00 p.m. Further, a Record Vote on the tax rate adoption will be held on September 16, 2014 at 6:00 p.m. at the regular City Council Meeting.
