#### Dear Patricia:

CaCo is hereby requesting approval for the extension of the Construction Phase Scope of Work; deemed Additional Services per Article 4.2 of our Agreement, as a result of the change in General Contractor to Nicholson Management Company.

### Scope of Work

- Project meetings starting November 14, 2022 and will occur every two weeks totaling approx. 12 meetings.
- 2. Nicolson stated the RFI process will be reinitiated.
- 3. Some of the previous sub-contractors may be replaced, some rework will be required due to non compliance to the drawings and possible shop drawing reviews may be required from new sub-contractors.

## **Project Schedule**

City of McKinney's intent is to complete the project before the Byron Nelson Championship, which begins May 8, 2023. Our fees are based on project completion no later that May 8, 2023.

CCA Landscape Architects, Inc. (formerly Caye Cook & Associates) submits this proposal for additional professional landscape services during construction due to the extensive delay in the project construction. Based on previous site observations, the landscape installation was near completion in the parking lot but had not started at the terminal. The following services will be provided as a not to exceed sum.

# **Construction Support Services** - Additional Fee

\$ 1,350.00

- Coordinate with Design team regarding construction issues for landscape and irrigation.
- Review submittals and address RFI's.
- Make 4 site visits to observe landscape irrigation installation including punch list and verification visit.
- Issue site visit report per visit.
- Visit site for punch list of landscape and issue report.
- Issue record drawings of landscape. Contractor to provide record drawing of irrigation since piping cannot be viewed in timely fashion.

We have \$380.00 remaining to bill in the previous construction support fee of \$2,000.00 which will be invoiced as services are rendered. The additional fee is in addition to the previous \$2,000.00 fee to cover all the services listed above.

Standard reimbursable expenses are included in the above fees. Billing will be submitted at the end of each month and at completion of services and is due and payable within two weeks of receipt of payment by Owner. Billing will reflect percentage of scope completed. Additional services to those enumerated above will be billed at a rate of \$135.00 per hour for Principal Landscape Architect, \$110.00 for Project Landscape Architect.
