Community Services Administrator Shirletta Best provided orientation to the

Commissioners. Commissioners were given orientation notebooks that include a

schedule of meetings for the year. Funding for grants is received from both city

and federal sources. CDBG funds are used for grant administration, public

services, housing, and economic development. The grant cycle for city funds

addresses the Community Support Grant which provides funding for non-profit

agencies and takes place during the fall. The Community Development Block

Grant cycle begins in the spring and allocates the federal funds. Applications are

vetted by staff members prior to presentation to the CGAC to ensure that all

pertinent information has been included and the agency is eligible. All applicants

are required to have an audit to be eligible. Following public hearings, the CGAC

will deliberate to decide funding amounts that will be recommended to the City

Council. The Community Support Grant funding this year is \$119,700 and will

fund approximately ten grants. The minimum CSG award is \$3,000; the

minimum CDBG award is \$5,000. The CDBG funding this year is \$730,747

which includes 20% for grant administration and 15% for public services. Focus

areas have been selected by Council and are listed in the five-year plan. Any

CDBG funds that are unused at the end of the year will be reallocated to the

following year.
