

ORDINANCE NO. 2016-08-\_\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AMENDING SECTION 62-106 OF THE CODE OF ORDINANCES TO CONCUR WITH THE TEXAS TRANSPORTATION COMMISSION WHICH ESTABLISHED A SPEED LIMIT ON THE CENTRAL EXPRESSWAY (US 75) MAIN LANES AND FRONTAGE ROADS IN MCKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62-106 of the Code of Ordinances to read as follows:

**Section 62-106 – Central Expressway (US 75) Main Lanes and Frontage Roads.**

When no special hazard exists that require a lower speed for compliance with this article, the speed of any vehicles not in excess of the limits in the section shall be lawful, but any speed in excess of the limits in each speed zone shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

- (1) Central Expressway (US 75) Main Lanes, which extends from Laud Howell Parkway to the southern city limits, a speed limit of 70 mph.
- (2) Central Expressway (US 75) Frontage Roads, which extends from Laud Howell Parkway to the southern city limits, a speed limit of 50 mph

Section 2. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 3. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2,000).
