• 2001 Charter Election

- 10 Propositions [All Passed]
 - 5 items for "general cleanup"
 - 2 items for "parliamentary cleanup"
 - 1 item to confirm the roles of the council vs the city manager
 - 1 item to set 3-year terms & term limits
 - 1 item to provide for a per meeting stipend

2004 Charter Election

- 2 Propositions
 - 1 item for "general cleanup" (passed)
 - 1 item to remove cap for per meeting stipends (failed)

• 2011 Charter Election

- 3 Propositions [All Passed]
 - 2 item for "general cleanup"
 - 1 item to shift from 3 to 4-year terms & clarifying term limits

2014 Charter Election

- 10 Propositions [All Passed]
 - 3 items for "council qualifications"
 - 2 items for "general cleanup"
 - 2 items to clarify council appointment/removal authority
 - 1 item to remove cap for meeting stipend
 - 1 item to fill council vacancies by appointment
 - 1 item to grant the fire department additional investigation powers

• 2019 Charter Election

- 2 Propositions [All Passed]
 - 1 item to reduce the signature threshold for a recall election
 - 1 item to clarify recall elections are voted on city wide


