

CITY COUNCIL REGULAR MEETING

JANUARY 18, 2011

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on January 18, 2011 at 6:00 p.m.

Mayor Pro-Tem Huff called the meeting to order at 6:00 p.m. after determining a quorum was present. Invocation was given by Council member David Brooks. Mayor Pro-Tem Huff led the Pledge of Allegiance

11-042 Mayor Pro-Tem Huff called for Consideration/Discussion/Action on Filling a Vacant Position on the McKinney Arts Commission. Council unanimously approved the motion by Council member Geralyn Keever, seconded by Council member Travis Ussery, to appoint Nina Ringley to fill the unexpired term on the McKinney Arts Commission ending September 30, 2011.

10-063A5 Mayor Pro-Tem called for a Public Hearing for Consideration/Discussion on the Request by Petsche and Associates, Inc., on Behalf of Blue Star Land L.P. and 206 McKinney, L.L.C., on a Petition to Annex Approximately 238.92 Acres, Located on the Southeast Corner of U.S. Highway 380 (University Drive) and Coit Road. Planning Director Jennifer Cox stated that Staff this is the second of three public hearings with no action required this evening. The final public hearing will be held on February 15, 2011 and at that time staff will be requesting action on the annexation, associated rezoning, and the associated development agreement. The first public hearing was held this afternoon at 4 p.m. Ms. Elizabeth Morris, Insight Research presented an economic analysis of the proposed annexed property. Ms. Morris stated that two analyses were run on this model, including the Fast-Tracker analysis and the Big Model Economic analysis. Side by side comparison was performed at a 20 year basis with equal results in the net cost benefit, direct employment, and taxes areas. Ms. Morris stated that the sales tax calculation was derived from the Bureau of Economic Development that average consumables

based on income levels as revenue US standards. Mr. Chaffin asked if there is a factor that you have placed in the equation reflecting how much of the sales tax actually stays in McKinney. Ms. Morris stated that she did not have that information but her assumptions are based on 100% stays in McKinney. Mr. Brooks suggested that if we ignore the breakeven point on schools we are harming the school districts. The last numbers he heard reflected that it costs \$55,000 to educate each student and we need to be careful to include the education cost as it is a large part of making a great community. Mr. Day agreed with Mr. Brooks' comments about the school but we need to remember in this case the retail should more than compensate what is lacking for the schools in the residential. Mr. Pete Petsche, 2600 Eldorado Parkway, McKinney, was available for any questions and there were none. Mayor Pro-Tem Huff called for public comment and there were none. Council unanimously approved the motion by Council member Ussery, seconded by Council member Keever, to close the public hearing.

Mayor Pro-Tem Huff called for Council and Manager Comments and Liaison Reports.

Council member Keever stated that she was invited by Senator Shapiro to speak at the press conference on Senate Bill 331 banning K-2. Representative Jerry Madden is sponsoring a companion bill in the House. Ms. Keever stated that the latest edition of the Texas Towns & City magazine includes an article regarding K-2 that she co-wrote with Tony Dale from Cedar Park. Ms. Keever mentioned that there will be a public workshop with the City Council, McKinney Independent School District, TxDOT, and the North Central Texas Council of Governments on February 21st.

Council member Day did not have any comments.

Council member Ricchi did not have any comments.

Council member Ussery thanked Staff for what they do day in and day out to make this the 5th best place to live.

Council member Brooks stated that the Veterans Memorial Board met last Wednesday night where they began selecting the materials for the Memorial Wall to honor the fallen soldiers. Construction for the Veterans Memorial should begin soon with an anticipated completion and public dedication in November 2011.

Deputy City Manager Chaffin thanked the Streets, Police, and Fire Departments for their work during the ice and snow on January 9th & 10th. The Streets Department spread 36,000 pounds of sand and ice melt. The Streets Department switched to 12 hour shifts with 161 man hours utilized to cover the 723 miles of streets. "Kudos to the Street Department for a great job."

Mayor Pro-Tem Huff stated that he participated in a meeting in Austin last week with TxDOT Aviation Advisory Committee. There are five Commissioners all appointed by the Governor. Mr. Huff took a tour of an Airport under construction on the north side of Houston where a man is spending \$45 million dollars for this airport. Main Street Board held a board meeting/retreat last week. There was a review of events in downtown. Mr. Huff stated that it is such events that made McKinney the 5th best place to live. There are tentative plans to again have a two day Oktoberfest in 2011. Each event this year will have a committee to drive it and not just staff. All board members will sign up for an event.

Mayor Pro-Tem Huff called for action out of Executive Session.

Council unanimously approved the motion by Council member Geralyn Keever, seconded by Council member Ussery, to approve an independent contractor agreement with Efren Ordonez for a one year term for services as an Associate Municipal Court Judge for the City of McKinney.

Council unanimously approved the motion by Council member Brooks, seconded by Council member Ricchi, to approve a settlement agreement with all parties in the City of McKinney vs. Fanning et al case under terms discussed in closed session.

Mayor Pro-Tem Huff called for Citizen Comments and there were none.

Council unanimously approved the motion by Council member Travis Ussery, seconded by Council member Geralyn Keever, to adjourn. Mayor Pro-Tem Huff adjourned the meeting at 6:56 p.m.
