

ORDINANCE NO. 2020-07-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2019-2020 ANNUAL BUDGET, TO PROVIDE FUNDING FROM THE CITIES OF ALLEN, FRISCO AND PLANO FOR THE DIRECT PROVISION AND ADMINISTRATION OF THE FOOD CARD ASSISTANCE PROGRAM, FROM THE COUNTY ALLOCATION OF "CARES ACT" FUNDING; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2019-2020 Annual Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2019-2020 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$1,625,000 in the County ILA COVID Response Fund for the Collin County allocation of "Cares Act" funding for direct costs (\$1,575,000) of the Food Card Assistance Program and administrative costs of the Collin CARES Emergency Housing and Living Assistance (EHLA) Program on behalf of the cities of Allen, Frisco and Plano.
- Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
