Proclamation

WHEREAS, On Friday, September 8th, 2017, Duane Metcalf, Jayne Langdon, Patricia Casarez and Erma Solis, in the performance of their duties as health care providers at Encore Wire Medcor On-Site Clinic helped save a life; and

WHEREAS, a 38 year old adult male arrived at the clinic, presenting with chest pains, shortness of breath and excessive sweating. Erma Solis, clinic receptionist and Patricia Casarez, clinic medical assistant, immediately noticed his poor color and that he appeared to be in distress; and

WHEREAS, Ms. Solis and Ms. Casarez assisted the patient to an examination room and quickly called for Jayne Langdon, clinic nurse practitioner and Duane Metcalf clinic director for assistance; and

WHEREAS, Mr. Metcalf advised upon entering the examination room, he saw that the adult male had lost consciousness; and

WHEREAS, Ms. Solis called 911, at this point the patient had no pulse and had only agonal type respirations. Ms. Casarez started CPR and Ms. Langdon was using a bag valve mask to assist the patient with breathing. Mr. Metcalf retrieved the Automated External Defibrillator (AED) and placed the pads on the patient's chest; and

WHEREAS the AED indicated the male was in course ventricular fibrillation, so Mr. Metcalf informed Ms. Casarez and Ms. Langdon to stop and step back and a shock was recommended. Mr. Metcalf pressed the shock patient button. After the shock was initiated the AED (led screen) indicated the patient had a sinus rhythm with some premature ventricular contractions and he had regained pulse; and

WHEREAS CPR was stopped and a non-rebreather mask was placed on the patient. Ms. Langdon and Ms. Casarez obtained vitals and continued to monitor his blood pressure, breathing and level of consciousness; and

WHEREAS, McKinney Fire/EMS arrived on scene within minutes and found the patient speaking to the clinic staff. The adult male was transported to the hospital; and

WHEREAS, the 38 year old male patient has returned to light duty after having a cardiac stent implanted; and

WHEREAS, The City of McKinney hereby recognizes Duane Metcalf, Jayne Langdon, Patricia Casarez and Erma Solis for their quick and courageous actions to help save a human life, working as a team to ensure the patient received immediate lifesaving medical treatment.

NOW, THEREFORE, I, GEORGE FULLER, BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF MCKINNEY, TEXAS, DO HEREBY ACKNOWLEDGE DUANE METCALF, JAYNE LANGDON, PATRICIA CASAREZ AND ERMA SOLIS AND SINCERELY THANK THEM FOR THEIR LIFESAVING EFFORTS AND SERVICE TO OUR COMMUNITY AND PROCLAIM SEPTEMBER 8, 2017 AS
