

**RESOLUTION NO. 2018-11-138**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN THE AMOUNT OF \$131,105.00 WITH FREESE AND NICHOLS, INC. FOR CONSTRUCTION INSPECTION SERVICES FOR THE CONSTRUCTION OF THE MCKINNEY SUBSTANDARD UTILITY REPLACEMENT AND STREET REHABILITATION UMBRELLA PROJECTS EAST OF SH 5 (CO1704) AND AUTHORIZING ANY SUPPLEMENTAL AGREEMENTS UNDER SAID CONTRACT UP TO THE AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF SAID SUPPLEMENTAL AGREEMENTS, OF \$145,000**

**WHEREAS**, the City Council of the City of McKinney, Texas has awarded a contract for the construction of the McKinney Substandard Utility Replacement and Street Rehabilitation Umbrella Projects East of SH 5; and

**WHEREAS**, construction inspection services are required to ensure the quality of the completed project meets the contract specifications; and

**WHEREAS**, the City has received a proposal from Freese and Nichols, Inc. to perform the construction inspection services during the construction of this project.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Manager is authorized to execute a contract in an amount of \$131,105.00 as well as all required supplemental agreements thereto, with Freese and Nichols, Inc. to provide construction inspection services related to the construction of the McKinney Substandard Utility Replacement and Street Rehabilitation Umbrella Projects East of SH 5 for a total aggregate contract amount, inclusive of any supplemental agreements, not to exceed \$145,000.

Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
