

**RESOLUTION NO. 2021-09-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING QUALIFIED FIRMS TO PROVIDE ON CALL ROADWAY PROFESSIONAL SERVICES AND ON CALL UTILITY PROFESSIONAL SERVICES AND AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS FOR PROFESSIONAL SERVICES**

**WHEREAS**, the City Council of the City of McKinney, Texas, approved a process to choose professional service providers; and

**WHEREAS**, the City of McKinney utilizes consultants to provide professional services related to various roadway design services; and

**WHEREAS**, the City of McKinney utilizes consultants to provide professional services related to various utility design services; and

**WHEREAS**, a request for qualifications was issued for on-call roadway professional services (21-41RFQ) and on-call utility professional services (21-42RFQ), and a pool of firms has been qualified based on the submitted statements of qualification.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**
