

**RESOLUTION NO. 2021-08-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING AND CORRECTING RESOLUTION NO. 2021-07-078(R); AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE PROFESSIONAL SERVICES CONTRACT WITH LAKE | FLATO + PARKHILL, OF FRISCO, TEXAS FOR ARCHITECTURAL AND ENGINEERING SERVICES, INCLUDING ADDITIONAL SERVICES, IN CONJUNCTION WITH THE DESIGN AND CONSTRUCTION OF THE MCKINNEY MUNICIPAL COMPLEX PROJECT (FC1707), MCKINNEY, TEXAS**

**WHEREAS**, the City Council of the City of McKinney, Texas, has determined the need for additional architectural and engineering services related to the McKinney Municipal Complex project; and,

**WHEREAS**, the City desires to extend the services of Lake | Flato + Parkhill for architectural and engineering services to include design development through construction administration related to the McKinney Municipal Complex Project (FC1707), including Additional Services; and,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The City Council of the City of McKinney, Texas hereby reconfirms its prior acceptance of the proposal from Lake | Flato + Parkhill to provide additional architectural and engineering services for design development through construction administration in conjunction with the McKinney Municipal Complex Project (FC1707) in the amount of \$6,624,116.00.
- Section 2. Resolution 2021-07-078(R) included the detailed amount of Additional Services which was part of the proposed amendment to the professional services agreement with Lake | Flato + Parkhill; however, the amount of Additional Services was inadvertently omitted.
- Section 3. The City Manager is hereby authorized to execute an amendment to the professional services agreement with Lake | Flato + Parkhill to provide architectural and engineering services from design development through construction administration, including Additional Services as described in Exhibit B of the Fee Proposal, related to the McKinney Municipal Complex Project FC1707 in an amount not to exceed \$7,418,671.50 which amount includes \$794,555.50 for Additional Services and an owner's contingency of \$100,000.00.
- Section 4. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
