Mayor Pro Tem Ussery called for Consideration/Discussion/Action on a 15-061 Resolution Authorizing the Interim City Manager to Execute a Contract and All Necessary Change Orders with Western Contracting for the Kings Lake Erosion Mitigation Project. Council member Pogue requested this item be pulled down for discussion. Director of Engineering Mark Hines stated this Resolution authorizes the Interim City Manager to execute a contract and all necessary change orders with Western Contracting for the Kings Lake Erosion Mitigation Project. Over the years, there has been a lot of erosion from the lake that goes right straight toward houses. We are going to go in and do some modular block concrete retaining wall to mitigate that. Council unanimously approved the motion by Council member Pogue, seconded by Council member Harris, to approve a Resolution authorizing the Interim City Manager to Execute A Contract And All Necessary Change Orders with Western Contracting for the Kings Lake Erosion Mitigation Project. Mayor Pro Tem Ussery called for Consideration/Discussion/Action on a Resolution Authorizing the Interim City Manager to Enter into an Agreement with Forest Park Medical Center. Council member Ricchi requested that this item be pulled down for discussion. Interim Human Resources Director Kathryn Usrey stated that in the past, we have brought to Council our strategies for working with individuals with chronic diseases. One of those in a primary targets for this year was diabetes. Our plan has not covered bariatric surgery in the past and we decided to add it as part of that diabetes management program. Part of the concern with diabetes is running into multiple morbidities and weight is one of those. We felt like we needed to have that option available. The City was approached by Forest Park Medical Center to offer a bundled package, which includes the pre-counseling, post counseling, and the surgery at a cost that is significantly lower than the market average. Ms. Usrey stated that this is a nonexclusive agreement and any medical providers that would like to partner with us can contact us with a competitive cost. Council member Kever stated that County Commissioner Hill stated that the County removed this procedure from their medical plan about five years ago because they were concerned about the magnitude of the applicants. Ms. Usrey stated that they will keep a close monitor on the number of these surgeries. Council approved the motion by Council member Ricchi, seconded by Council member Harris, to approve a Resolution authorizing the Interim City Manager to enter into an agreement with Forest Park Medical Center with a vote of 5-1-0, Council member Kever voting against.
