The Neathery Estate has become a living museum for guests from all over the world to enjoy. The home is also listed on the McKinney Historical Register. We have attached supporting documentation outlining the historic home, both defined by the architecture of the home and by the people that lived here.

In 2018 the home was professionally restored and opened to the public as a B&B. We provide the only B&B in the McKinney Historic District where guests can have an enhanced cultural experience staying in a restored historic home. The B&B provides unique one of a kind historical accommodations right in the heart of McKinney's Historic District.

- Improve signage for a better guest experience when navigating the property


