

ORDINANCE NO. 2014-10-XXX

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING ORDINANCE 2014-09-069 AND INCORPORATING 29.02 ACRES OF ANNEXED TERRITORY INTO THE BOUNDARIES OF CITY COUNCIL DISTRICT 2; PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE THEREOF

WHEREAS, on September 16, 2014, the City Council of the City of McKinney approved an ordinance which annexed approximately 29.02 acres of land located approximately 1,900 feet north of Eldorado Parkway and on the east side of Custer Road (Planning Department Case No. 14-144A) into McKinney's corporate limits;

WHEREAS, the ordinance which incorporated said land into the City of McKinney, Ordinance No. 2014-09-069, did not establish which City Council District the property would be located within; and

WHEREAS, the City Council of the City of McKinney has deemed it necessary to amend Ordinance No. 2014-09-069 in order to establish within which City Council District the property shall be located.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. Section 2 of Ordinance 2014-09-069 is hereby amended to read as follows:

"Section 2. The above described and illustrated territory lying adjacent to and adjoining said territory above shall hereafter be included within the boundary limits of the City of McKinney, Texas, and the present boundary limits of said City, at the various point contiguous to the area described and illustrated above, are altered and amended so as to include said area within the corporate limits of the City of McKinney, Texas. The subject territory shall be included with City Council District Number 2."

Section 2. Nothing in this Ordinance shall limit the City Council's authority to subsequently modify the limits and boundaries of City Council Districts under the City Charter.

Section 3. If any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.

Section 4. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney, and shall become effective upon such publication.
