

ORDINANCE NO. 2022-08-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS TO REMOVE THE REDUCED SPEED SCHOOL ZONE AND DESIGNATED CROSSWALK LOCATION AT THE INTERSECTION OF ALMA ROAD AND SILVERADO TRAIL FOR COMSTOCK ELEMENTARY SCHOOL AND MODIFY ORDINANCE SECTION 62-294 (3) OF WOODSON DRIVE SCHOOL ZONE FOR RUEBEN JOHNSON ELEMENTARY SCHOOL TO MATCH ACTUAL LOCATION IN FIELD; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62-294 (3) of the Code of Ordinances to read as follows:

Sec 62-294 (3) – Reuben Johnson Elementary School – Zone Designated

(3) On Woodson Drive beginning at a point 115 feet north of Vineyard Lane and extending northward along Woodson Drive to a point 50 feet north of Deer Run Drive.

Section 2. The City Council of the City of McKinney, Texas hereby repeals Section 62-344 (7), Section 62-344 (8), Section 62-344 (9), Section 62-344 (10), and Section 62-344.2 (2) of the Code of Ordinances

Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 4. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
