

**RESOLUTION NO. 2015-08- \_\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE 2015-2019 COMMUNITY DEVELOPMENT BLOCK GRANT CONSOLIDATED PLAN AND 2015-2016 ACTION PLAN, AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City Council, authorizes the City Manager to make application for Community Development Block Grant Funds (CDBG); and

**WHEREAS**, the U.S. Department of Housing and Urban Development will review and accept the 2015-2019 Consolidated Plan and Annual Action Plan providing CDBG funds for the 2015-2016 fiscal year to begin October 1, 2015; and

**WHEREAS**, the Community Grants Advisory Commission held three public meetings and prepared recommendations for Council acceptance of the Annual Action Plan and the Consolidated Plan under the use of Community Development Block Grant Funds, including allocation and carryover funds; and

**WHEREAS**, the U.S. Department of Housing and Urban Development will give final approval of the 2015-2019 Consolidated Plan and 2015-2016 Annual Action Plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The 2015-2019 Community Development Block Grant Consolidated Plan is hereby adopted with the Strategic Plan portion of the Consolidated Plan to be followed for the next five years.

Section 2. The 2015-2016 Action Plan is hereby adopted with funding allocations as follows:
