A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, IN SUPPORT OF A SUBMITTAL TO THE REGIONAL TRAFFIC SIGNAL RETIMING PROGRAM (RTSRP) AND MINOR IMPROVEMENT PROGRAM

WHEREAS, it is in the best interest of the citizens of the City of McKinney, Texas, to submit a proposal for Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program Call to North Central Texas Council of Governments (NCTCOG); and

WHEREAS, the Regional Transportation Council requires the submittal of a resolution as part of the Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program Call for Projects application submission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas, hereby supports the Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program submittal for the Call for Projects application.
- Section 2. The City Council of the City of McKinney, Texas, hereby authorizes an execution of all necessary documents for a submittal for the Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program Calls for Project.
- Section 3. The City Council of the City of McKinney, Texas, hereby authorizes the City of McKinney to serve as the public sponsor and lead project contact on this project and as such will designate a point of contact for the project.
- Section 4. The City Council of the City of McKinney, Texas, hereby acceptance of the Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program funds, if awarded.
- Section 5. The City Council of the City of McKinney, Texas, hereby authorizes a local match of 20% of the total cost of the Regional Traffic Signal Retiming Program (RTSRP) and Minor Improvement Program project.
- Section 6. The City Council of the City of McKinney, Texas, understands the City of McKinney will be responsible for any cost overruns, and all funding awarded by the Regional Transportation Council is provided on a reimbursement basis.
