A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING QUALIFIED FIRMS TO PROVIDE PROFESSIONAL SERVICES FOR MISCELLANEOUS DRAINAGE AND FLOODPLAIN MANAGEMENT SERVICES, MISCELLANEOUS SURVEYING SERVICES, AND MISCELLANEOUS GEOTECHNICAL AND MATERIALS TESTING SERVICES AND AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS FOR PROFESSIONAL SERVICES

WHEREAS, the City Council of the City of McKinney, Texas, approved a process to choose professional service providers; and

WHEREAS, the City of McKinney utilizes consultants to provide professional services related to miscellaneous drainage and floodplain management services; and

WHEREAS, the City of McKinney utilizes consultants to provide professional services for miscellaneous surveying services; and

WHEREAS, the City of McKinney utilizes consultants to provide professional services for miscellaneous geotechnical and materials testing services; and

WHEREAS, a request for qualifications was issued for miscellaneous drainage and floodplain management services (18-21RFQ), miscellaneous surveying services (18-23RFQ), and miscellaneous geotechnical and materials testing services (18-22RFQ), and a pool of firms has been qualified based on the submitted statements of qualification.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The following five firms are determined to be the most qualified to provide miscellaneous drainage and floodplain management services and will remain pre-qualified for a period of three years:

- Teague Nall and Perkins, Inc.
- Westra Consultants, LLC

Section 2. The following three firms are determined to be the most qualified to provide miscellaneous surveying services and will remain pre-qualified for a period of three years:

- North Texas Surveying, LLC
- JQ Engineering, LLP

Section 3. The following five firms are determined to be the most qualified to provide miscellaneous geotechnical and materials testing services and will remain pre-qualified for a period of three years:

- Professional Service Industries, Inc.
- Terracon Consultants, Inc.
- Fugro USA Land, Inc.
- Alliance Geotechnical Group, Inc.
- Kleinfelder, Inc.
