

## CAPITAL IMPROVEMENTS ADVISORY COMMITTEE

The Planning and Zoning Commission, along with Dr. Randall Hickman, met under its authority as the City of McKinney Capital Improvements Advisory Committee per resolution No. 95-02-11 (R) as amended by Resolution No. 2019-06-074 (R) in the Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, February 11, 2020 at 5:30 p.m.

Chairman Cox called the meeting to order at 5:30 p.m. after determining a quorum was present.

Chairman Cox called for public comments on non-public hearing agenda items. There were none.

Chairman Cox continued the meeting with the Regular Agenda Items and Public Hearings on the agenda.

**19-0010M2** Status Update on the Progress of the 2019 Impact Fee Update. Mr.

Aaron Bloxham, Planning Manager for the City of McKinney, gave a presentation on the progress of the 2019 Impact Fee Update. He explained impact fees, land use assumptions, an update is required every five years, and the different phases of the update process. Mr. Bloxham briefly discussed how they did the credit calculations and that the North Texas Municipal Water District had been included in the costs with this update. Mr. Brandon Forsythe, Kimley-Horn, 801 Cherry Street, Ft. Worth, TX, explained the Roadway Impact Fee Update and the calculations. He gave various examples. Mr. Matt Hickey; Birkhoff, Hendricks & Carter, LLP; 11910 Greenville Avenue; Dallas, TX; explained the Water and Wastewater Impact Fee Update and the calculations. He gave various examples of project expenses expected over the next ten years. Mr. Bloxham stated that Staff had been reviewing at all of the numbers and land uses in the 2019 Impact Fee Update. He discussed the timeline for the update. Vice-Chairman Mantzey had questions regarding the calculations. Mr. Bloxham explained it in more detail. No action was taken on this item.
